Must be read at the first meeting following receipt before being filed for reference.

- South Dakota Membership is currently at 94.69% so very close to the March 31 goal of 95% (and \$500 for the Department). Please call all annual members who have not yet paid their dues to see if they want to continue to be a member of our great organization. Dues not received by June 30, 2016 (at National Headquarters) will terminate the membership. After June 30, 2016, those prior members will need to reapply for membership and prove their eligibility.
- 2. ATTENTION AUXILIARY PROGRAM CHAIRMEN: Year-End Reports from your Auxiliary are due to the Department Chairmen before April 15, 2016. All report forms are included in this mailing. The Department Chairmen are required to have 100% reporting, so please send in or email your report before the deadline. If not received, expect a call from the Department Chairman to take the information over the phone. The Department Chairmen must compile their information from your reports to pass onto National Headquarters. So please be on time.
- 3. **The Outstanding Hospital Volunteer National Award application is due March 1** to Hospital Chairman, Leanne Payne. She will submit one application for further competition March 15, 2016. The application is included in this mailing.
- 3. South Dakota VFW & Auxiliary State Convention will be held June 9-12, 2016 at The Lodge at Deadwood. Registration form, hotel information, Advertising Form, and Hospitality Night form (for those seeking Department office) are included in this mailing.
- 4. Members are encouraged to check out the Benefits available to members. On the National website, <a href="www.vfwauxiliary.org">www.vfwauxiliary.org</a> click the Benefits tab to see what all is available. In particular, check out the Insurance Plans which includes Cancer Insurance (now available to individuals vs the entire Auxiliary needing to participate).
- 5. VFW & Auxiliary National Convention will be held July 23-28, 2016 in Charlotte NC. Registration, housing and tentative event schedule are available on the National website <a href="www.vfwauxiliary.org">www.vfwauxiliary.org</a>. The National Convention packets will no longer be mailed. ONLY Convention attendees will receive packets. Do not register unless you plan to attend.
- 6. Remember to check out the Program Blogs on the National website for program suggestions and how to get members and youth involved. There are also resources available to Auxiliaries and members

under the Programs tab; some titles are – Treasurer Tools, Tax Training for Treasurers, and Secretary Tips.

- 8. Department Treasurer, Carol Gross, has included information in this mailing regarding Auxiliary tax information. PLEASE take her message to heart as not filing the IRS 990N can negatively affect <u>any</u> fundraising events your Auxiliary does.
- 9. Department Chaplain, Mary Kirkvold, has included the Deceased Members Form in this mailing. The form is due to Mary not later than May 1, 2016 in order for the names of these deceased members to appear in the Memorial Service remembrance booklet.

What an honor to represent South Dakota at the National Mid-Winter Conference in Punta Cana, Dominican Republic. Traveling along from South Dakota were: Vickie Rosse, National District 23 Councilmember; Karen Sharp, Sr. Vice President and (daughter-in-law, Laurel); Jan Endes, Chief of Staff; Donita Mullinix, Department Guard (& husband, Tarzan); Nelda Jorgensen, Department Americanism Chair; and Deb Fahey, Christmas Tree Chair. All Department Presidents were treated to a lavish lobster and steak or red snapper for the 'Night on the Town'. There were two cocktail parties on the beautiful white sand beach and time to enjoy things like a tour of Santa Domingo and zip-lining.



It was good to see such a nice turnout for our Mid-winter/Legislative Conference in Fort Pierre. Since it was held a week earlier than usual, there were some changes in the schedule. Please let your Veterans of Foreign Wars and Auxiliary leaders know what you liked or didn't like. Your input is important, and will be considered when planning for next year.

I along with six (6) other Auxiliary members and two (2) potential members recently attended the National Mid-winter Conference in the Dominican Republic. It was my first National Mid-winter Conference, which I found very educational and informative. We worked hard, played hard and made it through all the airports with little delay. Next year's conference will be a five-day Caribbean cruise in late February 2017, and there is already information available if that sounds interesting to you.

I have no doubt that SD will achieve its next membership goal of 95% by the end of March and 100% by June 30<sup>th</sup>. These are not just numbers; it is literally cash in the bank for the Department, so we all need to keep working hard to make these goals a reality. National is going to propose a life-membership increase of 38.46% to 100%. When this will pass or when it will be implemented is yet unknown, but it could be within this coming year. Always encourage life membership, whether it is a new member or someone converting to life membership.

There will be at least six (6) other proposals to be presented at the National Convention. Regularly check the VFW Auxiliary website (vfwauxiliary.org) and the national magazine to keep up to date on what is going to be proposed, so that you can let the SD delegates know how you want them to vote. The line officers will also try their best to keep you informed.

You can now register online for the National Convention in July and also the Celebrate America's Freedom Event -- Mt. Rushmore, September 17, 2016. Also check the website for the coming year's Program Book as it will not be put out in a published format.

Check your audits and other transmittals to make sure that your Auxiliary is up to date, so that your Auxiliary is in good standing and will be able to vote at the State and National Convention. Help your Auxiliary officers out with transmittal dates for elections, delegates, etc.

President Nancy Worth called the meeting to order at 1 PM. Guard Donita Mullinex reported the badges were checked at the door. Opening Ceremonies were conducted according to ritual. Secretary Nancy Chester took Roll Call of Officers. All Council members were present except Historian Jennifer Little and Past Department Presidents on Council Neta Peterka and Vickie Williams.

Roll Call of Past Department Presidents: present were, Marva Barge, Nancy Chester, Thelma Dittman, Nancy Fickholm, Imogene Ellis, Jan Endes, Carol Gross, Mary Hammond, Connie Heggestad, Nelda Jorgenson, Sharon Mitchell, Mildred Ratigan, Vicki Rosse, Janice Vreim and Clara Wiedemer.

Roll Call of Auxiliaries: present were District 1 – Alcester 1, Canton 2, Beresford 2; District 2 – Brookings 7, Madison 1, Sioux Falls 4; District 4 – Goodwin 1, Milbank 2; District 6 – Aberdeen 2, Redfield 1, Huron 1; District 7 – Plankinton 1; District 8 – Pierre 12, Winner 2; District 10 – Custer 3, Sturgis 1, Rapid City 4, Deadwood 2.

Opening Prayer by Chaplain Mary Kirkvold and Pledge of Allegiance by Patriotic Instructor Nelda Jorgenson with singing of the National Anthem by all.

President Worth presented National Councilmember Vicki Rosse as Department Representative. She is from Brookings, South Dakota and immediate South Dakota Past Department President.

Reading of the minutes of the previous meeting: Junior Vice Carrie Alm motioned to dispense with the reading of the previous meeting since they were in General Orders. Conductress Sandi Moss 2<sup>nd</sup>. Motion Carried.

Reading of Official and other communications – Secretary Chester read Communication from 1) State of South Dakota - Dennis Daugaard Gov for participating in Christmas Around the World at the Capitol 2) Avera Walking Forward Group for cancer donation and 3) a thank you from Kay Rypinski for all who went to the retreat.

Treasurer's Report: Treasurer Carol Gross gave treasurer's report. Many auxiliaries are late with reports due January 31, 2016. Those auxiliaries are subject to having their charter pulled by National Headquarters if they do not come into compliance.

Audit Report: Janice Vreim gave report. Junior Vice President Carrie Alm motioned to accept the Audit Report. District #4 President Sharon Wellnitz 2<sup>nd</sup>. Motion Carried.

Budget Report: Budget Chair Janice Vreim gave budget report. Junior Vice President Alm asked about Miscellaneous Income definition. Misc Information - we get a percentage of funds sent into National for cards/labels/calendars as miscellaneous income.

President Worth asked all first time Legislative attendees to be recognized: Wanda Nix - Brookings, Cindy Williamson - Canton and Sue Jones - Pierre.

President Worth introduced Jan Endes, National Recruiter Trainer who will give training Monday at 9:30.

Reports of Committees, standing and special:

Veterans & Family Support – Patti Mitchell had nothing on Buddy Poppies but would like to see the meaning more widely publicized. President Worth explained that a Sioux Falls High School is now putting together Buddy Poppies due to lack of veterans with ability to do so. Mitchell reported that the 152 from Wagner and Rapid City will be coming home within the month. The Annual Day County Coyote Hunt will be held in February with proceeds going to South Dakota units and thanked everyone for their help. Mitchell was presented a National Outstanding Department Buddy Poppy Chariman Award for the 2014-2015 program year.

Americanism – Nelda Jorgenson reminded us of opportunities to get into schools to teach and remember home schools, 4H, Boy Scouts, Girl Scouts, etc to give short program. Adults are not immune to learning Patrotism and Americanism. Fly the flag. Jorgenson shared the Red Skelton what the pledge means.

Extension/Chief of Staff/National Recruiter Trainer – Jan Endes passed out a Health Checkup for Auxiliaries. Each District has at least one bachalor post and she encouraged we try to start an Auxiliary in each of them. There is a National Award offered for Auxiliaries in each Department for the best use of National Headquarters public information informing or revitalizing an Auxiliary and for a member who uses the National Headquarters public information. For the Auxiliary President Judging Committee - get your Auxiliary President information turned in before deadline - forms are available today.

Hospital – Leanne Payne reported trying to get volunteers to get awards. Seeing is believing at Hot Springs, Fort Meade, and Sioux Falls. They are all fabulous. Baby afghans are needed at Sioux Falls (about 40), pastel, and light weight. Needs lists for each of the hospitals was available. The new wards at Hot Springs and Sioux Falls are now open.

Legislative - no chairman was present. 8 am on Monday is the joint meeting with the VFW to present legislative issues to the group before the legislative mixture Monday evening.

Membership - Carrie Alm stated the Department was 90% by December 31 and is working on being 95% by March 31, 2016. We are at 93.91% now. She encouraged us to promote getting male members into the Auxiliary, we presently have 57 male members in South Dakota. We need 381 members to make 100%.

Scholarship - Sandi Moss. the VOD and Patriots Pen Banquet will be Monday. 29 Posts and 27 Auxiliaries participated in Patriots Pen with 1940 students participating and 94 Post entries advancing. VOD had 33 Posts and 32 Auxiliaries with all 7 districts participating. 942 students took part and 61 students advanced. Patriotic Art has had misuse of American Flag - use the flag code book to guide artists. Remember the home school students. Patriotic Art is due in March.

Youth Activities - Mary Kirkvold said the ROTC presented flags at the veteran's banquet in Sioux Falls and helped with the monthly breakfast. Ramdom Acts of Patriotism coins are available in sets of 100 for \$35. Year end reports are due in the Chairman's hands by April 15, 2016.

Chaplain Report - Mary Kirkvold has sent some cards.

Audit Committee - Junior Vice President Alm presented handout and made a motion to approve. District #4 President Sharon Wellnitz 2<sup>nd</sup>. Motion Carried.

Capitol Christmas Tree – Deb Fahey reported the Christmas Around the World was the theme and we had 500 ornaments on the tree. She described the tree and that each town had the names of their veterans listed in frames at the bottom of the treee. She asked everyone to pick up their photos before leaving.

SD Veterans Support Council - Kay Rypinski had brochure handouts and read the membership requirements for the SDVSC - only organizations are members. The council maintains the Avenue of Flags at the BHNC. They have three 25' flag poles with external halyards for sale at \$1000 each - these were a mistake as internal halyards are used at BHNC.

President Worth thanked Senior Vice President Karen Sharp for setting up the Legislative Meeting. There are 48 Auxiliary members and 44 Post members registered. September 17, 2016 Mount Rushmore will be visited by the National President and other Auxiliary members from across the United States as a Cafe Event.

District# 8 President, Nancy Chester reminded attendees of the silent auction items on the back table - funds go 1/2 to the State President's project - VFW National Home and 1/2 to the National President's project - VFW National Home.

Junior Vice President Alm gave information on the 2016 State Convention to be held June 9-12, 2016 at The Lodge in Dedwood. District# 10 is sponsoring the convention this year so there is more help available than in past years when one town sponsored the event. First forms are due by May 19, 2016.

Podium books are available from Treasurer, Carol Gross.

#### **Unfinished Business:**

Senior Vice President Sharp said that at the Fall COA it was noted that the President's Special Project was deleted in 2012. Article 1 Department as D which readed "Each year the incoming Department President may chose a funraising project as her Special Project. The project should state what the funds raised will be used for." Senior Vice President Sharp motioned to put Article 1 D back in as was in past with "may". 2nd by Conductress Moss. Motion carried.

#### **New Business:**

VFW National Headquarters had funds returned due to bad bank inforamtion. If your local Auxiliary did not get a refund on your life memberships check your ACH for your location.

July 23-27 is the National Convention in Charlotte, North Carolina. Conductress Moss made a motion to pay for three Delegates to attend the National Convention. Motion died for lack of a 2nd.

New Charters don't have the anniversay date of the original Charter. Please note the date on your original Charter and send that date to President Worth. Old Charters can be placed behind the new Charter in the same frame. President Worth asked District Presidents to present new Charters at the Spring District meeting.

# VETERANS OF FOREIGN WARS OF THE UNITED STATES AUXILIARY DEPARTMENT OF SOUTH DAKOTA STANDING RULES

## Updated January 31, 2016 COA

#### I. DEPARTMENT

- A. Budget Committee shall consist of five members: Senior Vice President, Junior Vice President, Chaplain, and one (1) Past Department President as Chairman, and one other appointed by the incoming Department President. The Department Treasurer shall prepare the budget for the next year. The committee shall meet prior to the Department Convention to establish the budget for the next year. Notification of time and place of meeting to be sent out by the Budget Chairman. Such budget shall be approved at the first Council Meeting immediately following Department Convention.
- B. Auxiliary Presidents' Judging Committee: The Chairman and Committee (not to consist of more than three [3] members) shall be appointed by the incoming Department President. The committee will prepare the judging criteria and publish in the first General Orders mailing. The Committee shall examine the reports of Auxiliary Presidents submitted at the end of the year. The committee shall serve as the "Judging Committee" to select the winners in the "All-State President" competition.
- C. Mileage shall be allowed for the purpose of exchange of paraphernalia from the retiring President, Secretary, and Treasurer to the incoming President, Secretary and Treasurer.
- D. Each year the incoming President <u>may</u> chose a fundraising project as her/his Special Project. The project should state what the funds raised will be used for.
- E. Mileage of thirty (30) cents per mile shall be allowed for all travel as set out in these Standing Rules from home station to destination and return. (6/6/2012)
- F. Hotel expense: Any Department Officer at the direction of the Department President, who travels more than 200 miles one way to an official function shall be reimbursed not to exceed \$70 for one night, should she/he choose to stay overnight. If adverse weather conditions occur and safety becomes a factor, it is at the discretion of the officer to make the decision to spend the night.
- G. Receipts for all vouchers expenses are required (including hotel) by everyone.

#### II. MILEAGE AND EXPENSES OF DEPARTMENT OFFICER

#### A. DEPARTMENT PRESIDENT

- 1. Mileage to attend:
  - a. One (1) day at the Fair
  - b. State Veterans Service Officers meeting (whenever there is a meeting)

  - a. To designated member of organization, appointed by the President, for on (1) trip to Institute an auxiliary and one (1) trip for a return visit within three (3) months after Institution for the purpose of instruction.
  - b. To Chief of Staff or a representative appointed by the President to visit a Post, if they are interested in forming an Auxiliary.
  - c. To Chief of Staff or a representative appointed by the President for trips to assist Auxiliaries who are having difficulties.

- d. To Audit Committee members and Department Treasurer to and from point of audit (Includes: Dept. Jr. Vice President, Dept. Chaplain, one (1) Council Member) each year for periods ending June 30 and December 31.
- e. To Convention Credentials Committee Chairman-to and from Department Convention.

#### C. HOTEL ALLOWANCES (General Fund)

- 1. Fall and Legislative/Midwinter Council of Administration Meetings
  - a. Department President her/his share, not to exceed one (1) night for Fall and two (2) nights for Legislative/Midwinter C of A meetings.
  - b. Department Secretary her/his share, not to exceed one (1) night for Fall and two nights for Legislative/Midwinter C of A meetings.
  - c. Department Treasurer her/his share, not to exceed two (2) nights for Fall and two (2) nights for Legislative/Midwinter C of A meetings

#### 2. Department Convention

- a. Department President her/his share, not to exceed four (4) nights
- b. Department Secretary her/his share, not to exceed four (4) nights
- c.. Department Treasurer her/his share, not to exceed four (4) nights
- 3. State Veterans Service Officers Conference: (If there is one)
  - a. Department President hotel shall be allowed.
- III. TRAVEL (General Fund) When mileage or airfare is utilized, the least amount will be paid. Airfare shall include baggage fee for one (1) bag. Round-trip mileage from home to airport to home will be paid.

#### A. National Convention

- 1. Department President Airfare and ground travel. Hotel her/his share not to exceed five (5) nights, and Two Hundred Dollars (\$200) expenses;
- 2. Senior Vice President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses;
- 3. Immediate Past Department President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses.

#### B. Big Ten Conference

- 1. President Airfare and ground travel. Hotel her/his share not to exceed two (2) nights, and Two Hundred Dollars (\$200) expenses;
- 2. Senior Vice President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses;
- 3. Junior Vice President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses.

- C. Midwinter Conference
  - 1. President Airfare and ground travel. Hotel her/his share not to exceed four (4) nights, and Two Hundred Dollars (\$200) expenses;
  - 2. Senior Vice President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses.
- D. Community Service/VOD Convention, Washington, DC
  - 1. President will be allowed up to Seven Hundred Dollars (\$700.00) expenses to attend the Conference.

#### IV. ALLOTMENT

- A. President Fifty Dollars (\$50) each month while in office.
- B. Secretary Fifty Dollars (\$50) each month while in office.
- C. Treasurer One Hundred Dollars (\$100) each month while in office.

Monthly vouchers to be submitted to Treasurer by end of each month to receive payment.

#### V. FUNDS AND RECEIPTS

- A. Special Funds: The Department Council of Administration or Department Convention may, from time-to-time, establish special funds for specified purposes. A special fund may be either permanent or temporary and shall consist of all monies received with the understanding that said fund is dedicated to the purpose indicated.
- B. All Department awards (not personal) received from the National VFW Auxiliary shall go into the General Fund.

#### VI. FUNDS AND EXPENDITURES (General Fund)

- A. All expenditures, either authorized or payments made shall, at all times, be made within and governed by the provision of the Department Budget.
- B. Vouchers and an itemized bill of purchases shall be submitted to the Department President for approval before the Department Treasurer will make payment. All bills shall be submitted for payment before or during the Department Convention for current year expenditures. All vouchers must be submitted to Department Treasurer no less than one
  - (1) month after the event covered by the vouchers.
- C. All parties receiving funds for hotel, airfare, ground travel, etc., shall send receipts of same to the Department Treasurer to be attached to vouchers supporting claim for payment or reimbursement.
- D. All expenses incurred, not covered by the budget, shall be submitted to the Budget

Committee for approval and voted on by the Council of Administration.

#### E. Authorized Awards

- 1. Three Hundred Dollars (\$300) Membership Award determined by Department Membership Chairman;
- 2. Two Hundred Fifty Dollars (\$250) Voice of Democracy Third Place Department Winner;

- 4. Forty Dollars (\$40) Each program chairman to be used at her/his discretion
  - a. Americanism, taken from the Americanism Fund.
  - b. Legislative
  - c. Youth Activities
  - d. Hospital
- 5. Fifty Dollars (\$50) each program chairman to be used at her/his discretion.
  - a. Scholarship Program
  - b. Veterans and Family Support/National Veterans Service
- F. State Fair Dept. will pay one (1) round-trip mileage for Auxiliary Chairman, and week gate pass, camping fee and parking fee for both VFW and Auxiliary Chairman be allowed (taken from State Fair Fund). Department will pay for one (1) golf cart not to exceed Three Hundred Fifty (\$350.00) yearly if VFW does not pay.

#### G. Contingencies

- 1. President One Thousand Dollars (\$1,000) payable upon receipt of vouchers by Department Treasurer;
- 2. Senior Vice President Two Hundred Dollars (\$200) payable upon receipt of vouchers by Dept. Treasurer;
- 3. Secretary Six Hundred Dollars (\$600) payable upon receipt of vouchers by Dept. Treasurer;
- 4. Treasurer One Thousand, Eight Hundred Dollars (\$1,800) payable upon receipt of vouchers by Dept. Treasurer;

#### H. Veterans and Family Support Scholarship Program

  - 2. Department Chaplain is responsible to send a memorial in deceased person's name to benefit a VFW or Auxiliary Program not to exceed Twenty-five Dollars (\$25) in case of the death of:
    - Department Officer elected or appointed, Program Chairman, including VAVS and deputy representatives, Past Dept. President of the VFW Auxiliary (includes husband, wife, child, mother, and father), VFW Dept. Commander, VFW line officers. NOTE: In case of the death of a Past Dept. President, her/his spouse, the Department President shall notify the President of the Past Presidents' Club.
    - The President is noted by two asterisks (\*\*) on the roster.
  - 3. The Department Chaplain is responsible to send remembrance, not to exceed (NTE) Fifteen Dollars (\$15). In case of hospitalization of the VFW Department Commander, Auxiliary Department Officer, Program Chairman, VAVS representatives and deputy representatives, or Past Dept. Presidents.
  - 4. Greetings to other Patriotic Organizations shall not exceed Ten Dollars (\$10) per organization.
  - 5. A love token not to exceed Twenty Dollars (\$20) shall be given each year from the Department for the National President's gift at the National Convention.
  - 6. The Department shall purchase a combined Podium Edition of the Bylaws and Ritual each year National Headquarters publishes revisions to be presented to the incoming Department President, Sr. Vice President, Jr. Vice President, Treasurer, Secretary, Chaplain, Conductress, Guard, Chief-of-Staff, Musician and all seven (7) District Presidents.
  - 7. Corsages/boutonnieres shall be provided (as deemed appropriate) by the Department to the Department President at the Big Ten Conference and Mid-Winter Conference banquets. The Dept. Sr. Vice President is responsible for the ordering corsages (working with Dept. Treasurer) for the Big Ten and Mid-Winter Conference banquets if: the Department has a National Council Member, National Director/Ambassador or Big Ten Officer/Chairman.
  - 8. Thirty Dollars (\$30) shall be allowed from Department Funds to purchase a gift and/or flowers to be presented to the outgoing Department President immediately following the National President's luncheon/dinner at National Convention. Incoming Dept. Sr. Vice President shall be responsible for purchase of gift and ensure all at Convention know location and time of luncheon/dinner, so they can be present for the presentation.
  - 9. Funds shall be allowed for four (4) first place All-State Presidents and four (4) runner-up awards. President to select awards to be presented. The four (4) membership categories are: 10-50; 51-110; 111-225; and 226 and over.

- MISCELLANEOUS ALLOWANCES (Department Convention Fund)
  - 1. The Department Convention Registration The Department shall pay for the Department President and National Representative.
  - 2. The Gold Star Family/Recognition Luncheon fee The Department shall pay for two (2) lunches per Gold Star Family in attendance, the Department President and the National Representative.
  - 3. Stipend Assistant Secretary Ten Dollars (\$10 for services rendered at the Department Convention.
  - Stipend Secretary Thirty Dollars (\$30) for services rendered at the Department Convention and to prepare Department Convention minutes within two (2) weeks following the convention.
  - Stipend Soloist/Assistant Soloist Fifty Dollars (\$50) shall be allowed for soloist at Dept. Convention. If soloist and assistant soloist both provide services, the Fifty Dollars (\$50) shall be divided between them - Twenty-five Dollars (\$25) each.
  - Stipend Musician/Assistant Musician Fifty Dollars (\$50) for services rendered at Dept. Convention. If Musician and Assistant Musician each provide services, the Fifty Dollars (\$50) shall be divided between them – Twenty-five Dollars (\$25) each.
  - 7. Memorial Book prepared by Department Chaplain not to exceed Seventy-five Dollars (\$75).
  - 8. Department Convention Committee to purchase corsages and boutonnieres for the Auxiliary President, Commander, and National Representatives to identify them throughout the convention.

#### VII. MAILING

- A. The Department Secretary in office shall prepare the Auxiliary roster as soon as possible after election of Auxiliary Officers in April of each year. The completed roster shall be provided to the incoming Dept. President for inclusion in her/his first General Orders. On the Past Dept. Presidents Roster, identify President of Past Presidents' Club with two (2) asterisks (\*\*).
- B. Beginning with the 2015-16 year, the Department Roster and Auxiliary Roster, all General Orders, Standing Rules, Special Orders, memorandum or bulletins, shall be emailed and posted on the Department SD VFW website (www.sdvfw.org) to all Auxiliary Department Officers, District Presidents, Dept. Chairman, all Auxiliary Presidents, Treasurers, and Secretaries, Past Dept. Presidents, National Auxiliary Council Member #23, VFW Dept. Commander, Sr. and Jr. Vice Commanders, Adjutant, VFW Dept. Headquarters, and VFW National Council Member. One (1) printed copy will be mailed to each Auxiliary President for distribution within the Auxiliary only by request or request by email only.
- C. It shall be the responsibility of the Dept. Secretary to update, make any corrections or additions of the Standing Rules each year.
- D. An updated electronic version (of the Standing Rules) shall stay in the possession of the VFW Auxiliary

Dept. Secretary and emailed to Assistant Secretary, the Treasurer, and the President.

#### VIII. MISCELLANEOUS

- A. The Department President may appoint an Assistant Treasurer, who may sign checks in the event the Department Treasurer is disabled. Before implementing, National Headquarters must approve the process.
- B. The outgoing Department President, Secretary, and Treasurer, shall prepare an inventory of the property in her/his possession that belongs to the Department. The inventory will be included in the convention Officers and Chairman Report Booklet. This inventory shall be turned over to the incoming Department President, Secretary, and Treasurer.
- C. Department will pay dues for the National SD Veterans Cemetary Support Council Chariman and Alternate, appointed by the Department President. Dues are \$25.00 for the primary and \$25.00 for the alternate.
- D. Member-at-Large dues will be Forty Dollars (\$40). (Resolution passed 6/16/2007)

#### IX. DISTRICT FUNDS

- A. Mileage to and from District meetings and one inspection to each auxiliary in the District to be paid to the District President upon submitting a voucher at rate approved by District.
- B. Each District shall purchase from District Funds, Bylaws and Rituals for all officers it deems necessary to carry out efficiently the work of the District (Department will provide to Bylaws and Ritual to District President).

#### X. HOSPITAL FUND EXPENDITURES (\$1.25 per member obligation)

#### A. Department President

  - 2. Department Convention to and from must attend the convention meeting the day that the Hospital Program awards are given in order to receive mileage to convention.
- D. Allotment VAVS and Department Hospital Representative Criteria established to qualify for stipend.
  - 1. Must plan and carry out an activity each month at facility;
  - 2. Must submit monthly report of completed activity;
  - 3. Must attend the Fall Council of Administration Hospital Workshop
  - 4. Established Stipend per year:
    - a. Ft. Meade One Hundred Eighty Dollars (\$180.000;
    - b. Royal C. Johnson One Hundred Eighty Dollars (\$180.00);
    - c. Hot Springs VA One Hundred Eighty Dollars (\$180.00);
    - d. SD Veterans Home One Hundred Eighty Dollars (\$180.00);
    - e. Yankton Human Services One Hundred Eight Dollars (\$180.00) (Shared);
    - f. Redfield Fifteen Dollars (\$15.00).
- E. Monthly allowance for activities at facilities:
  - 1. Ft. Meade One Hundred Fifty Dollars (\$150);
  - 2. Royal C. Johnson One Hundred Fifty Dollars (\$150);
  - 3. Hot Springs VA One Hundred Fifty Dollars (\$150);
  - 4. SD Veterans Home One Hundred Fifty Dollars (\$150);
  - 5. Yankton Human Services Center Ninety-three and 75/100 Dollars (\$93.75)
  - 6. Redfield Thirty-seven and 50/100 Dollars (\$37.50).

If any of the sponsored veterans' facilities (Fort Meade VA, Royal C. Johnson VA, Hot Springs VA, SD Veterans Home and Yankton Human Services) find they are in need of a special purchase to benefit veteran residents, the VAVS or hospital representative will request a letter of need be sent to the Department President and Treasurer with details of the need and the cost involved. As Canteen Books are needed by the above mentioned facilities, VAVS or hospital representatives will purchase the books and make them available to VA or hospital staff.

#### G. SPECIAL DONATIONS

- 1. Auxiliaries are encouraged to send more Hospital donations to the Department Treasurer, clearly marked to which facility funds are designated and if for a special purpose;
- 2. The Treasurer will include on the monthly report to VAVS or Dept. Hospital Rep. the amount of special donations and which auxiliary made the donation;

- 3. The Representative will then request the funds from the Department Treasurer using a vouchers and advising how the money will be spent.
- 4. The Representative is required to send a thank you to the auxiliary making the special donation(s).

## XI. - MISCELLANEOUS - Convention Memorial Service (Convention Fund)

- A. VFW Memorial Service A yellow rose shall be placed representing all deceased Auxiliary Members;
- B. VFW Memorial Service Green Wreath;

#### **AUXILIARY TREASURERS**

#### Dear Treasurers:

It has come to my attention that some auxiliaries have not filed the Form 990N for their income tax. ALL Auxiliaries are <u>REQUIRED</u> to file income tax every year. This is not up for debate, but must be done!

Form 990N is done completely online only. It <u>cannot</u> be filed by paper and sent. Those who did not file by November 15, 2015 for the 2015 auxiliary year (July 1, 2014 to June 30, 2015) will be required to file the longer form by paper. If you do not file for a period of 3 years, you will lose your non-profit status, and must pay the IRS a fine of \$400.00 and file a request to be able to file the 990N as a non-profit organization once again. (This is a lengthy endeavor, and is very complicated.) Otherwise your auxiliary will be required to file the longer form every year, and will not be considered a non-profit auxiliary, meaning you will have to pay income tax on all your income.

For general information, the Form 990N is very easy to file. You must go online, give them your EIN number and name of your organization (ex: Veterans of Foreign Wars of the US Auxiliary Dept of SD Auxiliary #1111, but you will have to insert your own auxiliary #) The form will ask if your auxiliary has income less than \$50,000.00 for the year. Then there are just 4 or 5 general questions to answer, and you are finished. Should take less than 5 minutes! And, if you do this on a timely basis each year, there is NO cost to you or your auxiliary.

As Dept Treasurer, I have been required to furnish the names and #'s of every auxiliary in the state of SD, the names of the treasurers, and their addresses to the IRS. And, I am required to do this every year. If you have not filed your 990N, I am assuming you will be contacted by mail from the IRS. They do not send communications through e-mail at all.

I have enclosed some of the information available with this letter. Please, Treasurers, do not ignore this. It is required of each of you.

Thank you for everything you do for the auxiliaries, your districts, and for your Department!

  - 6 points if 100% in Category 1 by September 1, 2015
  - 6 points if 100% in Category 2 by October 1, 2015
  - 6 points if 100% in Category 3 by November 1, 2015
  - 6 points if 100% in Category 4 by December 1, 2015
  - 5 points if 100% one month later than listed date
  - 4 points if 100% two months later
  - 3 points if 100% three months later

General Orders Bulletin #6

It's all about the "Buddy"® POPPY...... The little red flower that makes a big impact! No symbol, other than the Cross of Malta, so identifies with the Veterans of Foreign Wars. This little flower has served our cause well since 1922 when it was first introduced in a campaign by the VFW was using live flowers imported from France to the paper flowers we use today that are assembled by veterans. The purpose and importance has never changed. This flower makes an impact everywhere it goes, from its assembly by veterans, to the collection of donations for the Relief Fund, to its distribution to the public, to the use in displays. It can be used in so many ways and at every event you have!

Buddy Poppy: Here are some important things to consider when preparing for your Buddy Poppy distribution: Identify potential volunteers within your Post and Auxiliary and gather them together for an informational meeting explaining the purpose of the Buddy Poppy campaign. Choose high traffic areas and determine the number of workers you need to cover the locations. Ideal locations include storefronts, office or factory entrances and recreational areas. Make sure you get permission from the business owners before setting up shop. Post flyers around town in key areas such as the Post Office, coffee shops, gas stations, etc. It will let people know when and where they can get a Buddy Poppy. Remind your\_volunteers that they are not "selling" Buddy Poppies, but distributing them with the hope of getting donations. Sell coat hanger wreaths made out of Poppies. Use a child-sized wire coat hanger and bend it into a circle. Straighten the hook to make a ground stake. Wind the stems of about 50 Poppies around the wire to complete your wreath. Popular around Memorial Day. Make a "Wall of Remembrance" at your Post. Patrons can request a Poppy in honor of a loved one who has died. Their name gets placed on the wall with a Poppy hanging next to it. Honorees' names can be typed on note cards with the Poppies stapled to them. The red memorial flower that represents the Buddy Poppy is made by disabled or hospitalized Veterans. The money collected from the Buddy Poppy drives must be placed in your relief fund and only used to help our Veterans and their families. You can have a Buddy Poppy drive any time, but most are held around Veterans Day or in May. Talk to local youth groups and ask them to help with your Poppy Drive. Explain to the youths where our Buddy Poppy comes from and how they benefit our Veterans.

Every day the VFW and VFW Auxiliary are supporting our troops around the world. Our members offer support in so many ways: Sending care packages to deployed troops - Hosting send-off and welcomehome events - Assisting military families get through long deployments - And the list goes on and on.

We know how important troop support is because all of our members have been there. This is why the VFW Military Assistance Program (MAP) was created. It is the outstretched hand between the VFW and the local military, offering support around the world. Since 2005, MAP has sponsored events supporting more than 1.8 million service members and their families.

A large part of MAP is the Adopt-a-Unit program. Through Adopt-a-Unit, VFW Posts and Auxiliaries adopt hundreds of military units around the world. The goal of this program is to develop supportive relationships with units before, during and after deployments to help deliver the vast network of resources the VFW has available to the military. Here is some basic information about Adopt-a-Unit and how to get the funds you may need to do this great work:

- Why should you Adopt-a-Unit? To support your local military members & families To help connect military members with the network of resources the VFW has available - To help you recruit new members

- When should you Adopt-a-Unit? There's no time like the present! Our military members & families need you now more than ever. Your assistance is important whether they are home or deployed overseas.
- Where to get answers to Adopt-a-Unit questions? Call the Military Assistance Program office at 816-756-3390 or email at map@vfw.org
- How can you apply to Adopt-a-Unit? Submit an Adopt-a-Unit Application to the MAP Office. Find the form online at www.vfw.org/troopsupport.

# "Remembering Our Promise; Advocates for Veterans & Their Families" Bulletin #7, March 2016

President Nancy and I, along with several others, made our visits to the VA Hospitals and Veterans Home. WOW! is the way to start. As a first time visitor, it was an incredible experience and most informative!! We started with the Ft. Meade VA. We were most impressed with the new wing of the hospital which will open later this spring. It will have 3 new operating rooms along with all the things that go with it – private rooms for pre-op, waiting rooms, medical procedure rooms, etc. Listening to the leadership members talk about all the happenings was above and beyond what I could image – very impressive.

The next day was on to the new State Veterans Home in Hot Springs – you have to see to believe. We toured the old Home several years ago and have watched as the new was being built. It is the most high tech nursing home you have seen, really!! The couples apartments are large, have plenty of room and have bigger closets than we have in our house!! The bathrooms are fabulous as they are in all the rooms. Each room has their own bathroom with everything you would need in it. The kitchens for each pod is a kitchen we would each like in our homes. The main kitchen has a mixture of old and new, again with large ovens, frigs, etc. The 'sitting' rooms with several TV's, tables for cards/games, lounging chairs are color coordinated with their neighborhood. Down the hall is Main Street just like we have – Post Office, barber shop/beauty salon, library, chapel (Yes, they can call it a chapel), etc.

On to the VA Hospital was just the contrast. It is an old building, over 100 years old, with the native sand stone structure. I fell in love with the incline halls to transport patients from one place to another.

Each of these places provided a buffalo lunch which were outstanding and visiting with the residents added to the learning experience.

Down the road we visited VA Hospital in Sioux Falls. The wall that you see when you walk in is a must see! It has been years since I was there, so many changes and this was one of them. Again, they are doing some remodeling and their new PRIVATE rooms are just as nice as any hospital that I have seen – large, private bath, etc.

This whole experience was very humbling.

We did learn that the VA Hospital Volunteer services in Hot Springs have several needs that we have NOT addressed before:

- Coats, larger sizes for men and women
- Clothing of all kinds and sizes
- Shoes
- Toiletries
- Bedding of all sizes; sheets, blankets, towels, etc.
- Dishes except for cups
- Things needed to set up homes when you have nothing, such as small appliances: toasters, coffee pots, electric frying pans, pots and pans, etc.

Fort Meade VA Medical Center is not accepting knitted/crocheted blankets, bars of soup, outdated magazines and suits at this time.

They do need:

- Men's t-shirts and underwear is sizes small, medium and large
- Hard soled slippers
- Personal care items such as: full size shave cream
- Travel size body wash, denture adhesive, tooth paste and tooth brushes
- DVD's documentaries
- · Movies based on local region
- Coffee, creamer, sugar, sweetener, stir sticks
- Word puzzle and other activity books
- Cookies and coffee for waiting room at the Rapid City clinic

- "Here is our wish list for the SF VA:
- \*funds for the annual Women Veterans Conference to be held October 14, 2016 this year; funding is used for the noon meal, pens, and notepads; we have 150-200 in attendance coming from across our service area. It is an amazing site to have that many women Veterans in one location. We provide education, but really, it is a celebratory event recognizing the women Veterans for their service (they are often so invisible)
- \*Kuerig coffee maker for the WH Clinic waiting room would then need coffee supplies for it
- \* small refrigerator for staff breakroom
- \*bottled water for Veterans in WH Clinic a case per month
- \* multi-CD CD player relaxing CD's or funds so we can purchase CD's
- \*knitted and crocheted baby blankets (white or light pastel colors); about 40 Veterans using VA deliver babies per year. VA pays for the prenatal care and delivery; we don't provide it onsite. We follow these women during the pregnancy and send a small token of congratulations when the baby arrives. A nice touch is for the donor to pin a small note on the blanket as to which organization it is from or who made it.

We are having a retreat for women Veterans February 26 because it is Heart Awareness month and heart disease is the number 1 killer of women Veterans. At the retreat, the women will learn and practice yoga, have a lunch of heart-healthy foods prepared for them, learn from a speaker on toxic relationships (and how they can hurt your heart), and learn a meditative relaxation exercise that they can use at home. We have funding already for this event. However, that is something we host each February. This year, funds are being used for the meal, for journals (each woman will get one to write her goals to improve her heart health and journal about the journey to keeping the goals), and yoga mats for each participant to take home. This is an ongoing need, like the conference."

#2 is for the best activity in a nursing home for Veterans.

#3 will go to the Auxiliary that best promoted Military Suicide Awareness.

The VFW's legislative initiatives center on quality of life and health initiatives for all the nation's veterans, past and present. The list below details the VFW's 2016 legislative priority goals, with some details. It may look overwhelming – pick a few and focus on them.

#### **BUDGET**

- End budget sequestration.
- Adjust budget caps to reflect the growing demand on DOD and VA services.
- Provide sufficient funding for all VA budget accounts.

#### **ACCOUNTABILITY**

- Pass meaningful accountability legislation.
- Develop standardized staffing models and hiring practices throughout VA.
- Design Performance Measures that capture VA employees' quality of work not just quantity.

#### **HEALTH CARE**

- Expand timely access to direct VA health care through appropriate staffing models for each health care specialty, patient density thresholds for each VA medical facility, and a modular capital infrastructure that enables VA to adjust to changes in the veteran population.
- Reform and improve VA's Care in the Community process to ensure veterans have the choice to receive
  timely and seamless access to high-quality care in their communities when VA health care is not readily
  available. However, VA must remain the guarantor and coordinator of health care for all enrolled
  veterans.
- Consolidate all current non-VA care models into a single model.
- Modernize VA's scheduling system to ensure VA's scheduling process is seamless, veteran centric, and not susceptible to data manipulation.
- Expand the current caregiver benefits to those who care for severely injured, ill, and wounded veterans of all eras.
- Strengthen VA and DOD mental health programs to ensure service members and veterans who suffer from mental health conditions have access to robust mental health care services.
- Expand women's health care services to all VA medical centers to ensure the growing number of women veterans have access to gender-specific services.
- Authorize VA to receive reimbursement for non-service connected health care provided to Medicare beneficiaries.
- Ensure veterans who were exposed to toxic substances receive care and benefits for all associated health conditions.
- Properly fund homeless veterans programs to ensure the Administration is able to meet its goal of ending veterans' homelessness.
- Increase funding for VA research on the effects of Traumatic Brain Injury, how combat related injuries affect men and women veterans, and whether descendants of veterans who were exposed to toxic substances suffer from adverse health conditions associated with such exposures.

#### **COMPENSATION & BENEFITS**

- Fully fund the Veterans Benefits Administration (VBA) so that they can sustain the necessary workforce and IT systems to ensure claims are completed in an accurate and timely manner.
- Hold VBA accountable for the backlog of all claims and appeals, not just the compensation and pension claims that they define as their "workload."

- Ensure that VA exercise its authority to accept private medical evidence when processing disability compensation claims.
- Provide veterans the option to receive more timely appeal decisions by instituting the Fully Developed Appeals initiative.
- Demand that VA reverse its current policy that prevents veterans from submitting informal claims for benefits.
- Insist that VA improve its notification letter so veterans can understand the evidence used in making their rating decision.

#### TRANSITION ASSISTANCE

- Conduct discharge reviews for veterans who suffer from PTSD/TBI and who were discharged under Other Than Honorable conditions.
- Congress must properly fund homeless veterans programs to ensure VA can reach its goal of ending veteran homelessness.
- Improve Vocational Rehabilitation and Employment by removing the 12-year delimiting period and tracking veterans' employment placement for at least 12 months post job placement.
- Ensure the Transition Assistance Program curricula meets the needs of service members and all veterans at all phases of the transition process.

#### **EDUCATION & EMPLOYMENT**

- Protect the integrity and future sustainability of veterans' education benefits.
- Invest in developing small business opportunities for veterans.
- Ensure service members receive civilian credentials or academic credit for the professional training they receive during service.
- Insist that the federal government meets its veteran hiring and contracting obligation.

#### **DEFENSE & HOMELAND SECURITY**

- Fully support U.S. troops and their mission to fight the war on terrorism, as well as to protect our nation's citizens and interests around the world.
- Halt the development and/or proliferation of weapons of mass destruction.
- Fully fund and deploy a U.S. missile defense system.
- Secure America's borders.

#### **MILITARY QUALITY OF LIFE**

- Ensure DOD maintains a quality and comprehensive benefits and retirement package that is the backbone to a quality all-volunteer force.
- Preserve the integrity of TRICARE to ensure service members and their families have timely access to high-quality health care.
- Protect service members' and their family members' on-base quality of life programs.
- Pass full concurrent receipt of military retirement pay and VA disability compensation.
- Eliminate the SBP/DIC offset for surviving military retiree spouses.

#### **POW/MIA**

- Achieve the fullest possible accounting of U.S. military personnel missing from all wars.
- Ensure Congress fully funds the POW/MIA Accounting mission.
- Insist the U.S. government keeps POW/MIA recovery a national priority.
