

DEPARTMENT OF SOUTH DAKOTA VETERANS OF FOREIGN WARS OF THE UNITED STATES May 2019 General Orders #11 "Providing Top Cover"

May 1, 2019

- 1. There will be no General Orders for June 2019. Instead, please submit your report for the 89th Department of SD Annual Convention and Council of Administration **Book of Reports** by **June 3**.
- 2. **Membership**. All State Officers and District Officers are asked to assist Posts in membership. This is necessary for the Great State of South Dakota to achieve 100% membership this year. We must all work harder this month as time is running short with only 59 days until the end of the membership year. Please help your membership drive by putting on a push now to attain your Post membership quota.
- 3. Audit Reports. Has your Post sent in its last Quarterly Audit Report yet? A review indicated that some Audit Reports are missing, catch them up to date, as they are very important. It is the Post Commander's responsibility to insure that they are sent in on a timely basis. If you don't know what reports you have sent in, call the State Office to find out. If your Post has **not submitted** the Quarterly Audit Reports for the year of 2018-2019, all representation of your Post at the Department Convention shall be deprived until the proper adjustment of such deficiencies are presented to the proper authorities, at such time representation shall be **restored** promptly.
- 4. **Special Olympics**. Posts are asked to send their 2019 donations for the Special Olympics Fund to VFW Department headquarters. We have donated \$1,390 so far however our goal is \$1,500. All Posts are asked to be generous and put us over the top.
- 5. VFW Buddy Poppy distribution will be conducted under the authority of Section 711, page 98 of the National By-Laws and Manual of Procedure and according to the rules of the National Buddy Poppy Committee. Posts are reminded to order their Buddy Poppies and to complete arrangements for their year's poppy distribution. Order forms are posted on the Web site, <u>vfwsd.org</u>. According to the National By-Laws, Section 219, all net proceeds of the distribution of Buddy Poppies shall be credited to the Post Relief Fund and also deals with authorized expenditures from the Post Relief Fund account.
- 6. **Installation of Officers**. Attention is called to Section 217, page 71, Manual of Procedure. The Post Commander-elect will select the installing officer who holds or has held a rank at least as high as that of Post Commander. Post officers shall be installed in their respective offices prior to the convening of the Department Convention, but shall not assume their duties until the Department Commander is installed. The installation may be conducted publicly at an open meeting. Officer-elect who may be absent for good and sufficient reason or cause may be installed at any regular or special meeting prior to the Department convention. If not then installed, the office will automatically become vacant. Officers shall be elected for a term of one (1) year except that three trustees shall initially be elected for terms of one (1), two (2) and three (3) years and thereafter one (1) trustee shall be elected each year for a term of three (3) years.

- 7. **District Commanders**. Attention is called to Section 417, Page 79-80 of National Manual of Procedures concerning elected District Officers at the District Convention or Spring Meeting. Nomination, election and installation shall be in a manner prescribed in the Manual of Procedure. The District Commanders will be installed again at the Department Convention on June 16, 2019 as a member of the Department Council of Administration.
- 8. 2019-2020 Post Election Report. This form was mailed out by National Headquarters to the Posts and with instructions to return the completed document directly to National Headquarters. We are asking the Post to make a copy and send that copy to the State Headquarters so that we will know the election report has been completed. It is very important that the election report forms are completed in the time allowed or your Post or District will be removed from the rosters at National Headquarters. The deadline is June 1, 2019 and if your election report is not in by the deadline, your Post will be put on the suspension list immediately. There will be no grace period. All positions must be filled and a member is not allowed to hold more than one elected office, see Section 215 and 216, Eligibility for Office and Elected and Appointed Offices, page 15-16. If the election report is not sent in on time the Post and Officers will not receive any information from National and your dues notices will not be sent out to your membership.
- 9. Delegates, District Convention & Meetings, Department and National Conventions. Reference National By-Laws, Section 222, Page 76. Post delegates and alternates to the Department Convention shall be elected at a regular meeting of the Post held not less than thirty (30) days prior to the Department Convention with one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post at the time of the election. The Department Quartermaster shall verify the delegate strength of each Post using the month-end membership report immediately prior to the convening of the convention or as the Department By-Laws so provide. Delegates and alternates of each Post shall be members in good standing in the respective Post within the Department. Review your meeting date making sure it is at least 30 days prior to June 13.
- 10. **National Convention Delegates**: Reference National By-Laws, Section 222, page 17. Each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25.00), which shall entitle the Post to a packet of Convention information materials and one identified registered delegate for the National Convention. Each additional attending delegate attending the National Convention will pay a ten-dollar (\$10.00) delegate fee.
- 11. **Judging for the All-State team** of District Commanders, Post Commanders and Post Quartermasters will be on May 4, 2019. All report information must be received at State Headquarters by COB May 3, 2019. Please refer to the 2018-2019 Department Membership Program Booklet for details on these contests. A copy is on the South Dakota VFW web site and may be downloaded by going to <u>vfwsd.org</u>.
- 12. **2019 Department Convention** will be held on June 13-16, 2019 in Madison, hosted by Post 2638. Convention information is included in the VFW Web site at <u>vfwsd.org</u>.
- 13. **Commemorative Dates**. Reference Section 223, Page 76-77 of Manual of Procedure. Each Post shall make arrangement s for observances of Memorial Day. See that suitable grave markers and United States Flags are placed on the graves of deceased members and if practicable, conduct Memorial Day Services in the cemeteries in its locality. Each Post shall see that suitable arrangements are made for the observance of Loyalty Day, Flag Day and Veterans Day. In addition, the Posts should arrange special ceremonies, and all Commanders should alert comrades to their obligations for appropriate commemoration of other dates specified in the Ritual. Remember to report details of these events in your Community Service Report.
- 14. **Peace Officer Memorial Day**. The United States Flag shall be flown at half-mast until noon on May 15, 2019. All Posts are requested to comply with this order.

- 15. Unpaid Bills & Expense Vouchers. All members with unpaid bills and expense vouchers that have been incurred during this administration are hereby requested to submit the same for payment by May 25, 2019 so that payment can be made prior to the closing of the books for the fiscal year ending May 31, 2019.
- 16. **Contributions**. All Posts that have not done so are urged to contribute \$0.35 cents per member to the Department Hospital Fund, \$0.20 cents per member to the Department Service and Rehabilitation Fund and \$0.10 cents per member to the Memorial Park Fund. All donations should be received at Department Headquarters by **May 3, 2019**.
- 17. National By–Laws, Section 213, page 14-15, Arrearages: Any Post in arrears for any financial obligation to District, Department or National, for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, page 39, failing to ensure that the Post is properly insured in accordance with Section 709, page 40, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

"EIN"

!!NOTICE!!

The Department of South Dakota State Office is the holder of a group exemption letter for all the Posts in the state that have an "EIN" (Employer identification number) number and the new rule effective immediately is that the "State Office" is responsible for updating the information for each subordinate Post (which is anyone in the State that has an EIN number). We maintain a list of Posts and numbers and now are required to update that list to the <u>Department of the Treasury</u> yearly. They used to send the list to us and we would update it and send it back. We now have to maintain the list and send to the Treasury. If you have an "EIN" number it is necessary that you file a 990 yearly or if you miss 3 consecutive years you will lose your tax exemption. To help us help you it would be nice if you would send us a copy of your 990 when you file yearly so we can help you stay out of trouble. Things we must have we will take off your election report and that being "Post address, city, Post Quartermaster". This is the result of not submitting:

The IRS <u>must</u> receive the updated information or signed Declaration 90 days before the end of your annual accounting period. FAILURE TO REPLY COULD RESULT IN THE LOSS OF YOUR GROUP EXEMPTION LETTER.

Dear Comrades, Brothers and Sisters,

Just completed District meeting. It was grand to see another VFW Post, that I have never been too. Thank you, Mitchell, for hosting. A new experience and wow, all 26 steps worth. Soon to be 86-year young Howard Martin enjoyed it. He also enjoyed the pickup ride up from Gregory. I signed him out from the Assisted Living.

State Surgeon Colin Reisner gave an informative speech on retaining young people. It is so true on what he stated. Let's not run off new members, let alone the young people. I remember my first state convention, I was preregistered. I stepped up to ask how to sign in. (Crystal, you were not there) Me polite, baby faced Boxa at the time, and a 20-year VFW veteran at that, got the "what are you doing here" treatment. The people at that table never took to mind, a 20-year Military Service Career as well, before the VFW years which included several overseas assignments and deployments. A 20-year military career with task after task after task, responsibility after responsibility completed without reservation. In my service in the air force and there are others, you also got a boat load of extra appointments.
