ARTICLE 10 – STANDING COMMITTEES AND DUTIES

SECTION 12 – Baseball amended to read:

The State Commander shall appoint a Baseball Advisory Committee that consists of the State Commander, State Adjutant, State Quartermaster, State Baseball Chairman, Director of Baseball Operations, Assistant Director of Baseball Operations (when filled) and Representatives from Class AA (when participating the previous season), Class A, Class B and one (1) At-Large Class Representative totaling nine to ten (9 - 10) members. Quorum for the Annual Meeting shall be Five (5) Baseball Advisory Committee members. The SD VFW Baseball Advisory Executive Committee shall consist of State Baseball Chairman, Director of Baseball Operations, Assistant Director of Baseball Operations (when filled), State Quartermaster. Each Post or Community that registered a team will receive a delegate vote at the Annual Meeting for each team they registered the previous season. Only Baseball Advisory Committee members or Team Coaches are authorized to vote. Select Baseball Rules will be determined at the Annual Meeting and posted to the SD VFW Baseball website. There will be a State Tournament for each active Class in each Division.

General Orders from Judge Advocate

Wow time has gone by so fast I hope we all had a good year and I trust That we all worked very hard to make it successful, but also took time to enjoy our friends in the VFW. I have worked frantically to get your reports recorded and then they were put in the Dashboard at the Head Quarters. I see there is still some time please work on getting them in to the State office so We can get them recorded. I have enjoyed Being in the role I have been in this year and hopefully, I will be in same roll next year

Please do two things for me before the end of the year June 30. Get all your deceased that are on your rosters report to National because they are offering a one time amnesty period. I know if your like Aberdeen we lost 40 + people during Covid and now it's time to scrub our roster. And I won't draw you out, but you know who owes me what reports so let's get them in shall we? There will be so many changes in the year ahead. Don't freak out they are all good they will make life easier so with that I will be happy to see you at the State Convention.

Greetings,

Did you know that your honor guard could receive money for providing rights for funerals? Currently the rate is \$50, but come July 1, 2022, the rate will go up to \$100. I know there are many posts that provide honor guard that do not utilize this opportunity, but you can use this money to help purchase uniforms or other items you see fit. This is money sent to you by the State of South Dakota.

Is your claim taking a long time to be decided? A "normal" claim (which is a horrible term for claims) take roughly 180 days. There are different ways that a claim can be slowed down and I will list some of the more common ways. How the claim is filed, meaning are you going to send in more information after you filed the claim, and are you requesting the VA to request medical documentation from non-VA facilities. When you have the VA request the documentation that can add up to 60 days on the claim, and even than some facilities do not send your records. Some of the factors are is a Blue Water Navy claim because then the VA wants to prove you were on the ship and when, and also pull the ships logs for the Latitude and Longitude to ensure you were within the parameters. The other issue with Blue Water Navy claims is only a few regional offices (I believe 5) actually process these claims at "specialty sites" which slows the claim down. There are a few other claims that also go through "specialty sites" and there is 1 type of claim that there is only 1 Regional office that looks at them. I will commend the Dakota's Regional Office in Sioux Falls, SD and Fargo, ND for their speed and accuracy on getting claims taken care of, and we are very fortunate to have them for our claims.

Hot update is the VA has issued an interim final rule establishing the following presumptive conditions for Service in Southwest Asia Theater of Operations:

- Squamous cell carcinoma of the larynx
- Squamous cell carcinoma of the trachea
- Adenocarcinoma of the trachea
- Salivary gland-type tumors of the trachea
- Adenosquamous carcinoma of the lung
- Large Cell carcinoma of the lung
- Salivary gland-type tumors of the lung
- Sarcomatoid carcinoma of the lung
- Typical and atypical carcinode of the lung

I would encourage that if you have any of these conditions to please get your claim established.

Comrades, let's talk a bit about the All American Dashboard.

Take a look at the last four letters in American, yes it states, "I can."

We need to apply that to the dashboard. The dashboard is here to stay, and it really is an awesome way to input our reporting. At this point in time the only person who may input information to the dashboard is the adjutant, which makes that officer very important.

Planning and developments are currently underway to increase the number of officers that will share responsibility for the dashboard. Department of South Dakota VFW Commander Barbara has told me "Exciting BIG CHANGE is coming soon!" We need to meet that change with an **[I CAN]**.

Department of South Dakota VFW currently has 8 Posts who have completed all the requirements on the Dashboard, with one more post pending. That is a little under 20% of our 52 VFW Posts. Looking at the other side of the coin, we only have 5 posts who have not "met" any of the dashboard requirements. That is about 10%, which shows that the other 70% of our posts are working hard and inputting dashboard program items.

South Dakota VFW Department QM Anna is well versed on all aspects of the dashboard and is willing to provide training and support to all of us.




