#### VFW Celebrates as Landmark PACT Act is Signed into Law

**WASHINGTON** — After years of persistent advocacy, National Commander of the Veterans of Foreign Wars (VFW) Tim Borland, families of loved ones affected by toxic exposures and other veteran service organizations,

stood together behind President Joseph Biden at the White House as the SFC Heath Robinson Honoring Our Promise to Address Comprehensive Toxics Act of 2022, the landmark bill focused on assisting toxic-exposed veterans, was signed into law, Wednesday morning.

"What an honorable moment in history for veterans!" exclaimed Borland after the event. "The PACT Act becoming law is the largest expansion of veteran benefits since the creation of the VA. My sincerest thanks to the members of Congress, I am so proud of all the hard work VFW staff, our Action Corps and VFW members everywhere did to push Congress to pass this bill and was honored to represent our organization at the White House on this historic day."

The PACT Act, as it's commonly known, is named after Sergeant First Class Heath Robinson who passed away in 2020 from conditions related to toxic exposure during his service in the military. The comprehensive bill expands health care for generations of veterans who up until now had the arduous task of proving their conditions or illness a result of service-connected exposure to toxic substances or environments, such as the burn pits many Post-9/11 veterans were exposed to during deployments to Iraq and Afghanistan. The bill enacts VA provisions for 23 presumptive conditions for rare respiratory diseases and cancers and creates a framework for the establishment of future presumptions of service connection related to toxic exposure.

"Too many of our brothers and sisters have succumbed to illnesses connected to toxic exposure," said Borland. "That is why this bill has been the VFW's #1 priority for the past few years, and we weren't going to give up until it was passed."

Passed by the Senate on Aug. 2, the bill was in limbo for almost a month as procedural hurdles, amendment considerations, and shaky support among some Senators caused the bill to stall before it was passed overwhelmingly with a vote count of 86 – 11. For almost a week leading up to the final vote, VFW members, PACT Act advocates and other veterans held a fire watch on the grounds of the U.S. Capitol, holding a constant vigil for six straight days until it was announced the bill passed.

"With one voice, we told Congress 'Every veteran counts' and they listened," said Borland. "I encourage every eligible veteran to join the VFW, so we can continue to secure and improve the health and benefits for veterans, service members and their families. The veteran's voice has strength, and it is even stronger when we are all together."

The PACT Act is the latest achievement on the long list of legislative victories the VFW has fought for since its inception, part of the legacy of the VFW's veteran advocacy that continues to carry on into the future.

"After 123 years, the VFW continues to show we are alive and well, and that 'No One Does More for Veterans,' because for the VFW 'EVERY VETERAN COUNTS!" said Borland.

Greetings Veterans,

I am sure most of you have now seen that the PACT ACT did in fact pass. With these two additional presumptive were added to Agent Orange exposure which are hypertension and Monoclonal gammopathy of undetermined significance (MGUS). With this change for Agent Orange is also the opening of the exposure to include Thailand, Laos, and Cambodia. Guam was also added, and their timeframe is much longer. Roughly 20 more presumptive were added to the Gulf War and Post 9/11 veterans, and due to the list of them I would recommend contacting your local County, Tribal, or State Veteran Service Officer for clarification. You are also more than welcome to contact me on the list, but I will give caution as currently there are a lot of unknowns to if there is going to be specific criteria to these conditions. One thing that I saw that I thought was great is that with some of the cancers listed for the Gulf War state "of any type." This is key because before with cancers they would connect some of the types, but not all. One question I have been getting asked a lot is can I file my claim now on the new presumptive, and the answer is yes. The catch to filing now is the date of claim will be adjusted to October 1, 2022, and by the way, the PACT ACT was written the VA may not even look at the claim until January 1, 2023, at the earliest. Now some of the claims are being pulled now to start the process, but it is not guaranteed as with the influx of claims to be filed means the Veterans Benefits Administration needs to hire more people to process the claims. Fortunately, some of the offices had been able to start adding to their teams proactively and appears that they will be adding many more here coming soon. In October at the Fall Council of Administration, I will be teaching a Post Service Officer class, and in the later part of the Class, I plan on going over more of the PACT ACT. I have some great VFW Service Officer Training scheduled in September and after that training, I am sure I will know more. I also want to briefly discuss the Camp Lejeune Lawsuits with the water contamination and exposure. There has been discussion on this topic to include if this could affect your VA benefits and compensation. The recommendation that has been given from the National Veteran Services team is to file all Camp Lejeune presumptive through the VA first and to NOT sign a contract with any attorneys with the lawsuit currently. The reason why is because when it comes down to it a person very well may not be able to keep both awards, and that some money could be recouped later. The lawsuit is what is considered a tort claim and as being as such normally a veteran is not able to receive both payments and must forfeit one. In the end looking at things it would be better for the veteran to file the claim with the VA for benefits, as the veteran and their families would benefit more through that than any lump sum that may be paid out.
