Following are Proposed Amendments to the Department of South Dakota Bylaws submitted to the Department Resolutions & Bylaws Committee.

For reference and comparison, the current Department of South Dakota Bylaws are on the Department website (www.vfwsd.org), under the Resources, Bylaws and Dept. of SD tabs.

This posting will serve as notification to the VFW Posts of South Dakota in accordance with Article 18 (Amendments) of the Department of South Dakota Bylaws.

PROPOSED AMENDMENTS TO DEPARTMENT BYLAWS

ARTICLE 6 - PER CAPITA TAX

ARTICLE 6 – Change Heading to Read as follows:

ARTICLE 6

ANNUAL PER CAPITA TAX AND ANNUAL DEPARTMENT DUES

ARTICLE 6, SECTION 1 – ADD at the beginning of the first sentence:

SECTION 1: Annual Per Capita Tax:

ARTICLE 6 – ADD Section 2 as follows:

SECTION 2: Annual Department Dues: In accordance with Section 506 (Department Dues) of the National Bylaws the Department at its Annual Convention will assess Department Dues of not less than fifty cents per annum on each member in good standing in each and every Post within its jurisdiction. Annual Department Dues may be designated for and in the amount the Annual Convention deems appropriate for Programs to include the Hospital Fund, the Service and Rehabilitation Fund, the Memorial Park and Chapel Fund and/or any other Project or Program decided at the Annual Convention. Annual Department Dues will be based on Post membership as of June 30 of the previous Membership year and payable to Department Headquarters not later than October 1 of each year.

<u>ARTICLE 9 – COUNCIL OF ADMINISTRATION</u>

ARTICLE 9, SECTION 2 – DELETE as follows:

District #1 – Delete Post #3728, Freeman and Post #5770, Crooks.

<u> ARTICLE 10 – STANDING COMMITTEES AND DUTIES</u>

ARTICLE 10, SECTION 9 – REVISE to read:

The State Commander shall appoint a Veterans Council that consists of the current State Adjutant as a continuing appointment and two (2) At-Large members, preferably one (1) from the East side and one (1) from the West side of the State. The purpose of this Committee is to sit on the South Dakota Veterans Council as a member representing the Department of South Dakota Veterans of Foreign Wars and to join with other veterans' organizations to provide services that benefit South Dakota Veterans and their families.

<u>ARTICLE 16 – MISCELLANEOUS</u>

ARTICLE 16, SECTION 5 – REVISE to read:

SECTION 5: In accordance with Section 703 (Bonds) of the National Bylaws each Officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an Indemnity Company as surety in a sum at least equal to the amount of the Liquid Assets for which, so far as can be anticipated, they may be accountable. The Department has interpreted Liquid Assets as Cash on hand, or an asset easily converted to Cash, such as Savings Accounts, Electronic Funds Transfer, Cryptocurrency, Treasury Bills, Treasury Bonds, Certificates of Deposit, Stocks, Bonds, Mutual Funds, Money Market Funds and Exchange Traded Funds. Each and every District and Post within the jurisdiction of the Department of South Dakota Veterans of Foreign Wars shall Bond with the Indemnity Company designated by said Department.

SECTION 6: Renumber current Section 5 to Section 6

If you have not submitted Reports regarding Programs you have participated in enter them on the State and National Dashboard as appropriate immediately.

Post and District elections should be completed at this time. Installation of Officers must be completed prior to the convening of the Department Convention but shall not assume their duties until the Department Commander is installed. **Election Reports should be submitted to National Headquarters not later than June 1**st to avoid **Suspension.** Just a reminder that two Posts had their Charter revoked this year due to their failure to submit an Election Report.

Insure you review the Proposed Department Bylaw Amendments that are included in these General Orders as they will be voted on during the Department Convention.

Again, Posts are reminded to submit their Delegates and Delegate Fees for both the Department and National Conventions. The Department Convention is scheduled for June 15-18 in Mitchell. Registration and Delegate information is included in these General Orders. Please consider attending as your input is important to the continued success of our Department.

Greetings Comrades,

It looks like nicer weather is finally approaching. Claims continue to be extremely busy and PACT Act claims are continuing to come in. The VA has added numerous new positions because of the high number of claims. There are a couple things to remember with this though. First it will take some time to get them all trained, and the second problem is many of the folks that were hired came from other similar positions such as Department, County, and State Veteran Service Officers. It will take time to hire and train the new people back filling those positions. They added 48 new BVA Judges to bring the total number up to 131. This has really helped with the backlog of appeals waiting to go before the board.

There have been many questions about the deadline of the CLJA Tort claim which is in 2024. That is the deadline to file a civil claim, but you can still file a VA Compensation Claim after that. There has been a lot of back and forth on can you get the Tort Claim and Disability. The VA has said verbally that you can receive both but the actual wording in the law says they can recoup any money that you receive. I can say the one certain thing is, if you go with the Tort claim, be cautious of which

lawyer you go with. The VFW is recommending Bergmann and Moore. Bergmann and Moore are charging 33.3% of the total award. Other firms are charging you costs, which are unknown and then 50% of the remaining amount. If you have questions on the process, reach out to Service Officer before you sign a contract with any lawyer.

According to **National Bylaws Section 222 (a)** the Delegate strength shall be one for every thirty members or fraction thereof in good standing. The Delegates and Alternates shall be elected in accordance with the Manual of Procedure.

Also enclosed is a Delegate fee form. According to **Department Bylaws Article 5: Conventions**, **Section 6** a fee of one dollar (\$1.00) is required by the Department for each Delegate. Voting strength of each Post is the member who are in good standing at the time of the election. Each Post shall remit fees for any members from their Post who are qualified to receive a vote according to National Bylaws Section 504 Governing Body; Composition and Section 521 Voting. This would be Post members who are serving as a member of the current Department Council of Administration, current National Council of Administration, serving as a Post Commander within the Department and any Past State Commander. Any Post member possessing more than one qualification for voting at the Department Convention shall have no more than one vote.

The Delegate Credential Sheet and Delegate Fee Form **must** be filled out and sent to State Headquarters by June 1, 2023. For example, if your Post is allowed 10 Delegates and only two attend the Convention, the two who do attend the State Convention shall be entitled to vote the full Delegate strength to which the Post is entitled.

Please remember to have your Post Delegate Registration Sheet and your Delegate Fee Form and payment sent to the State Office by June 1, 2023.
