General Orders February 2024: Dept SD Jr Vice Commander

The Department of SD as of Jan 31, 2024 has 6051 Life members, 71 new members, 25 reinstated members and 586 continuous paid members. As of Jan 31, 2024 we are at 92%. We still have 172 unpaid members and 345 expiring members in the Department. Our goal is to reach 102% so we need 675 more paid members to reach our goal.

We did recruiting at County Fair in Mitchell in January, picking up 3 new life memberships for the VFW. We also raised \$4,500 for District 7 and the Dept SD Commander's fundraiser.

I attended the Legislative Conference in Pierre. I made contact with my local legislators who are very supportive of Veterans and Veteran's bills that our Dept supported. VFW Post 2750 from Mitchell submitted the nomination for Teacher of the Year (Susan Farrell-Poncelet) from the high school category.

I plan to assist the Commander at the Rapid City Stock Show in recruitment efforts on Feb 1, 2024. I plan to continue to assist the American Legion Post 18, DAV Chapter 27 and 40&8 service organizations in Mitchell. We were successful in having the DAV van repaired for Davison County VSO's, VA, and Dept SD DAV.

I plan to attend District 7 meeting on February 18 in Armour.

The VA Stakeholder's was cancelled this month due to the Veteran's Council being held at the same time. I do not have any updated information from them this month.

Winter has given us a bit of a break at the end of the month. I hope you are enjoying the better weather. Be cautious of the slick spots though in the morning. The thawing is great but freezes at night causing hazards. It is a good time to look over your homes to ensure there are no hazards before winter decides to come back.

I know I talk about this all the time, but reach out for help if you cannot do it you cannot do it yourself. Every post has members that are willing to help. If they cannot help, they will probably know someone who can assist.

Greetings Fellow Member,

I hope that everyone had a happy and safe holiday season. I would like to give everyone a close-out of 2023 in the claims area. The VFW currently represents 12,961 members. Those that received grants in 2023 received \$3,472,544.84 in one-time Retro Payments and \$93,157,022.82 in on-going compensation payments. These amounts are dollar payments only and do not include medical and educational benefits.

There has been a huge increase in claims due to the PACT Act along with all other claims. With the VA's system of how they handle claims now, have increased the wait time on decisions. Many new positions have been added across the country so hopefully we will see these times decrease. To better understand the process and why it takes so long to get that decision, I would like to show you the 8 Step Process to Claims procedures.

STEP 1. FILE AN INITIAL CLAIM WITH VA Submit your claim to VA Claims Intake Center by mail or fax in person, at a VA Regional Office, or through an Accredited Representative or VSO.

STEP 2. VA RECEIVES CLAIM Your claim has been received by VA. To confirm receipt of your claim, you can check eBenefits or call VA at 800-827-1000. If you submitted your claim to VA by U.S. mail, VA asks that you allow mailing time plus one week for them to process and record receipt of your claim. VA will send paper notification to confirm that your claim was received. The claim will go into the cloud awaiting someone from a Regional Office to pull the claim out.

STEP 3. UNDER REVIEW VA assigns your claim to a Veterans Service Representative for review to determine if additional evidence is needed. If VA doesn't need any additional information, your claim will move directly to the Preparation for Decision phase. If VA decides that it needs additional medical evidence to decide your claim, they will schedule a Compensation and Pension examination for you.

STEP 4. GATHERING OF EVIDENCE The Veterans Service Representative will request evidence from the required sources. Requests for evidence may be made of you, a medical professional, a government agency, or another authority. It is common for claims to return to this phase, should additional evidence be required.

STEP 5. REVIEW OF EVIDENCE Once all the requested evidence is received, a Veterans Service Representative will review the evidence. If it is determined that more evidence is required, the claim will be sent back to the Gathering of Evidence phase for additional development.

STEP 6. PREPARATION FOR DECISION The Veterans Service Representative recommends a decision and prepares documents required to detail the decision. If more evidence is required, the claim will be sent back in the process for more information or evidence.

STEP 7. PENDING DECISION APPROVAL VA reviews the recommended decision and approves the final award. If it is determined that more evidence or information is required, the claim will be sent back in the process for more information or evidence.

STEP 8. PREPARATION FOR NOTIFICATION VA prepares your entire claim decision packet for mailing.

In-between each step, the case is put back into the cloud and waits for someone to pull it out for the next step. Your case is not worked by one individual from start to finish. Some cases have had up to 12 different people touch the case before a decision was sent out. If you have any questions, reach out to me or another Veteran's Service Officer.
