Greetings Comrades,

September is upon us; school is in session and hunting season is around the corner. It has been a busy summer on the claims side. PACT Act cases continue to be filed and processed. There have been some additions to the PACT Act as far as locations, time frames and conditions. I would like to remind everyone that the PACT Act and Burn Pit/TOXIC Exposure Registry are two different things. When you register for the Burn Pit/Toxic Exposure registry online, you will be set up with an appointment for a screening and exam. That is separate from filing a claim for disability so you will still need to see a Veteran Service Officer to get that completed. Even if you already have a service connection, I highly encourage everyone to register online and get your exam completed. If they add new conditions down the road, it will be easier to get a grant if they have been discussed already in the Burn Pit/TOXIC exposure exam.

We are still getting a lot of questions on the conditions listed in the PACT Act. People are just filing claims for all the conditions in the PACT Act and then are upset when those conditions are denied. Just because a condition is a presumptive does not mean you will be automatically granted. You still need to have a diagnosis of having the condition and show that it is an on-going problem. You also need to demonstrate that you were in an approved area at the approved timeframe listed.

Another trend that we have been seeing is people requesting an increase in a condition that they are already service connected for. If that condition has not gotten worse, be very careful about asking for an increase. Check with a VSO and have them check the CFR for your condition and they can tell you what you would need for an increase. Once you open a condition, it can also be DECREASED. If any condition is anything other than 0%, be very careful with re-opening it. If are combined 100% rating, you only have one direction to go and that is down so be careful.
