Installation of Officers: Attention is called to Section 217, page 73, The Post Commander-elect will select the installing officer who holds or has held a rank at least as high as that of Post Commander. Post officers shall be installed in their respective offices prior to the convening of the Department Convention, but shall not assume their duties until the Department Commander is installed. The installation may be conducted publicly at an open meeting.

Side note: On the 1st of June, if you have not submitted your Election Report, you will receive a letter from the Commander-In-Chief suspending your Post. At such time, the Department Commander will issue a follow-up letter and establish a committee to oversee Post business. All Post business must be overseen by the established Committee which includes any meetings, disposition of property, financial transactions, etc. PLEASE submit your Election Reports in a timely manner. March - Nominate, April - Elections, May - Installation, June - take office when Department Commander does.

The Department of SD as of Feb 24, 2024 has 6011 Life members, 88 new members, 32 reinstated members and 628 continuous paid members. As of Feb 24, 2024 we are at 93.71%. We still have 168 unpaid members and 322 expiring members in the Department. Our goal is to reach 102%. So we need 602 more paid members to reach our goal.

We plan recruiting at Pheasants Forever 1-3 March Sioux Falls, SD, and County Fair in Mitchell in 11-17 March We plan to sell raffles for District 7 and the Dept. SD Commander's fundraiser at County Fair. Anyone one who wants to help is welcome.

March 2024 General Orders

I hope that everyone has enjoyed the mild month of February, but winter is not over. We still need to be prepared for cold and snow. We have had some blizzards in March and April. It looks like March might come in like a lamb so be prepared for it to go out like a lion.

I attended this February's VHA/VBA stakeholder's meeting VIA Teams. Home health care was the main topic of discussion. If qualified, there is home health care available to disabled veterans. There are 2 tiers of health care available.

- 1. Non-skilled health care
 - a. They will teach routine skills.
 - b. Filling Pill reminders.
 - c. These are skills that can be accomplished without specialized training.
- 2. Skilled health care
 - a. These are more specialized skills that can be done at home.
 - b. This to assist in the transfer from the hospital or short-term health care back to the home.

- c. This can include at home and community care.
- d. Some examples would be wound dressing, catheters, IVs, physical therapy, etc.
- e. Some of these skills can be taught to Caretakers while others are accomplished by the VA coming into the home to assist.

Mother nature is again as unpredictable as ever. If you need anything, please reach out to your local post for assistance. We are all here to watch out for each other and our families.

Greetings Fellow Members,

The weather is getting nicer and hopefully spring is close around the corner. Now is a good time to reach out to our members that may be less mobile and see if there are any outside projects that we can help with. This will give you time to line up help and plan for any needed projects.

With some of the legislation that is currently in the works at the state capitol, I have been getting a lot of questions of who is available for these. Each step up in a VA percentage rating, there are additional benefits that are available. The current proposals are based on being 100% Permanent and Total or commonly referred to as 100% P&T. That is different than being 100%. A Permanent and Total rating means that there are no future exams. If a condition can change, then it will not be Permanent and Total, and a future exam will be scheduled. A way to look it is, if the condition can improve or change, it is static. An example is cancer. It could go into remission, so will not be P&T unless the medical diagnosis lists it as terminal. To get the benefits such as, CHAMPVA, 38 USC Chapter 35, SD property tax exemption, SD special license plates, and SD park entrance fee waiver, you need to be 100% P&T. Being 100% does not qualify you for those benefits.

As stated earlier, each step up on the percentage scale adds additional benefits so see your VSO or contact me for the list. There are some of the steps that we call the big steps that add notable benefits.

30% - You can add your dependents.

40%- Automobile grant/special adaptive equipment

-SD hunting and fishing Card-\$10 for 4years

50% - VA health care Priority Group 1

-If military retired/available for Concurrent Retirement and Disability Payment

70% - Nursing Home at VA expense

100% -Dental treatment at VA

- -DOD commissary privileges
- -Specially Adapted Housing
- -DOD ID cards for dependents

100% P&T - Discussed above.

If you have any questions, contact your local Veteran Service Officer or get a hold of me. I like to remind everyone, whether or not you have a VA rated disability, you are eligible for mental health care from the VA.
