Election Report Reminder

We want you to remember that on the 1st of June if the Commander-In-Chief has not received your Post/District Election Report, your Post/District will be suspended. At that time, the Department Commander will issue a follow-up letter to establish a committee to oversee the Post business. All Post business will then be overseen by the established committee.



INSTALLATION OF OFFICERS

SECTION 217, PAGE 72, MANUAL OF PROCEDURE

The Post Commander-elect will select the installing officer who holds or has held a rank at least as high as that of Post Commander. Post officers shall be installed in their respective offices prior to the convening of the Department Convention but shall not assume their duties until the Department Commander is installed. The installation may be conducted publicly at an open meeting.

An officer-elect who may be absent for good and sufficient reason or case may be installed at any regular special meeting prior to the Department Convention. In not then installed, the office will automatically become vacant.



Every Post and District should continue to work on membership. As of March 24, 2025, District 1 is at 96.54%. They need 92 members to reach 102%. District 4 is at 98.93%. They need 34 members to reach 102%. District 6 is at 103.85% - congratulations! District 7 is at 100.76%. They need 11 members to reach 102%. District 10 is at 94.33%. They need 62 members to reach 102%. The Department SD is at 99.08%. They need 204 to reach 102%. We have until June 30, 2025 to make 102%. Let me know if I can help your Posts and Districts with recruiting in any events you have

There is a lot of talk currently going around the web that the VA will change the ratings for Sleep Apnea starting this April. Some sites even have the ratings percentages broke down. Please keep in mind that this is being discussed in proposals and has not yet been approved. The criteria for Sleep Apnea have been discussed for the last few years so I am sure that there will be a change at some point but what that final change is and when it will take place is still to be seen. Historically, when the VA makes a change to a rating, if you already have the rating, it will remain at what you are rated unless you make any claim related to that condition or you already have a future exam scheduled for that condition. As in the condition is not permanent and total. If changes are made and become final, the VA will put out a notice. Make sure you are getting information from reputable sites and if you ever have a question, reach out to your local VSO or call our office.
