In today's world—where fewer people carry cash—this is an easy way to meet people where they are and increase participation.

#### **Greetings VFW Members**

We are entering the pumpkin spice season. That wonderful time of year to spend time with friends and family and eat way too much food. No regrets. The last few months have been extremely busy. We assisted National VFW at the Sturgis Motorcycle Rally. We staffed two locations at the Rally and assisted 340 Veterans. We then rolled right into the State Fair. Over the course of the fair, we assisted another 300 Veterans. Although these two events alone took many staffing hours to fill, it was well worth it for the number of Veterans we were able to help.

After the State Fair, we conducted our Annual Training event in Sioux Falls at the Military Heritage Alliance Building. This training was for all County and Tribal Veteran Service Officers across our state. We also had attendees from other Service Organizations. We presented numerous classes during the week that covered basic claims submission, pension, health care, CHAMPVA, appeals process and many others. We also had presenters from the Veterans Administration, C&P providers, SAVE training and others. At the completion of the training, all attendees completed a skill level test to maintain their certification.

After the states annual training, I headed to Annapolis for the VFW's annual Service Officer Training. The VFW always does an excellent job on keeping us all up to date on all the new changes and trends that are going on within the VA. One of the items that were being discussed throughout are the changes that VA would like to put in place for some conditions. Some of these are not new and have been discussed over the last few years. A big one is Sleep Apnea. The current proposal would reduce the 50% rating if you are on a CPAP. They contend, if you are on a CPAP, then the condition is controlled. We have already seen that it is getting much more difficult to get this condition granted than it did a year ago. Another of the changes would be to get rid of tinnitus as a separate rating and just roll it into hearing loss. The main take-away is that we need to make sure we follow and keep up on any changes that the VA may be proposing for disability benefits.
