Installation of Officers: Attention is called to Section 217, page 73, The Post Commander-elect will select the installing officer who holds or has held a rank at least as high as that of Post Commander. Post officers shall be installed in their respective offices prior to the convening of the Department Convention, but shall not assume their duties until the Department Commander is installed. The installation may be conducted publicly at an open meeting.

Side note: On the 1<sup>st</sup> of June, if you have not submitted your Election Report, you will receive a letter from the Commander-In-Chief suspending your Post. At such time, the Department Commander will issue a follow-up letter and establish a committee to oversee Post business. All Post business must be overseen by the established Committee which includes any meetings, disposition of property, financial transactions, etc. PLEASE submit your Election Reports in a timely manner. March - Nominate, April - Elections, May - Installation, June - take office when Department Commander does.

During the month of February, I attended the American Legion mid-winter conference to work on future planning and coordinating VFW and American Legion conventions, so they do not overlap. I also made plans to attend Memorial Day services at the National Cemetery in Sturgis so we can plan the services hosted by the VFW at the National Cemetery in 2026. In addition, I put a proposal to have the mid-winter convention in Mitchell in 2029. I also helped plan and organize District 7 mid-winter meeting with Commander Dennis Pense and his staff. The Department of SD bylaws have the process that bylaw amendments are accomplished see below:

It would be nice to have the bylaw change request before Fall Council or Legislative Workshop so the bylaw committee can discuss.

**Congressional Charter** 

Sec. 502 - Bylaws.

The Department Convention may adopt or amend Bylaws governing the Department as prescribed in the Manual of Procedure, provided such Bylaws do not conflict with the Congressional Charter, Bylaws, Manual of Procedure, Ritual or laws and usages of the Veterans of Foreign Wars of the United States.

Manual of Procedure

Sec. 502 - Bylaws.

Copies of Bylaws, including amendments, adopted by a Department shall be forwarded to the Commander-in-Chief, through channels. No Bylaws or amendments adopted by a Department shall become effective until reviewed by the Commander-in-Chief or their designee for compliance with the Congressional Charter, Bylaws, Manual of Procedure, Ritual or laws and usages of the Veterans of Foreign Wars of the United States.

Department of South Dakota Bylaws

#### **ARTICLE 18 AMENDMENTS**

SECTION 1. These Bylaws may be Amended at any regular session of the Department Convention by two-thirds (2/3) vote of the members present and voting, providing a thirty-day (30) notice to the Department is given from those listed in Section 2 of this Article so the Department can give a twenty-day (20) notice, including the subject, of the proposed Amendment has been given to the Posts in the call for the meeting. No Amendments shall be effective until the same has been forwarded through channels and approved by the Commander-in-Chief.

SECTION 2. Amendments to the Department Bylaws may be proposed by any member in good standing, any member of the Council of Administration, the Resolutions and Bylaws Committee or any District or Post chartered by the Department of South Dakota provided the proposal meets the notice requirements outlined in Section 1 of this Article.

SECTION 3. Wherever these Bylaws or subsequent amendments may be found to be in conflict with the present or any future National Bylaws, the latter shall prevail and be binding upon this Department as though written herein.

Greetings Fellow Veterans,

What a roller coaster month both in weather and in government. Let's hope the warm weather is on the way and clearer guidance comes on Veteran's concerns.

Let's touch on the first topic that everyone is concerned about. The current word from the White House is that Veteran's Benefits will not be touched. What they are looking at is the Federal workforce. Currently they are saying that essential positions within the VA system are not affected. Some positions that were previously remote tele-work are being told that they will have to come back to working within an office. There are some stipulations that some may still work from home. So, the big take-away is that no one really has a solid answer yet of what is going to happen for sure or how it will look when the time comes. Again, at this time there is NO PLAN TO CUT VETERANS BENEFIT PAYMENTS.

There are several bills going through the State Legislature, that have already been brought up, that can affect some benefits of Veteran's withing our state. I am not telling you which way to support but I will say make sure you make an informed decision and read through the bills in full.

There have been a lot of questions on education benefits that go along with the changes in MGIB, Post 9/11 Bill and Chapter 35 benefits. The best answer to give you is to apply for the benefit. If you have passed your education benefit to your dependents, have them apply. Even if you believe that you have used all your benefit that is available, you may now have additional benefits available to you. They will then send an eligibility letter stating whether you have eligible benefit left. These two sites will be helpful in explaining some of the changes.

The VA will be doing away with My HealtheVet and ID.me. They will be going to VA.gov. This site will be a one stop site. You will be able to make and track appointments, refill prescriptions, get your disability and benefit letters and track any claims along with other options. You will need to set up an initial log-in if you have not done so yet. The below link will help.

Claims are continuing to be filed at high volumes. Current wait times on claims can be up to a year and a half. The best way to shorten this time and get a positive claim back quicker is documentation. Make sure you have all your supporting documents, statements, and medical records ready to go with the claim. Even if statements are not required, they can really help get a positive claim with a higher rating. A big one, is make sure that your condition that you are requesting is diagnosed in your medical records.

#### **Requirements:**

- Email address **NOT** used with another person's ID.me account
- MUST have access to the Email provided at the event
- Smart Phone
  - Must be a U.S. number NOT international, U.S. territories, or Google Voice
- 2 forms of identification (driver's license, social security card, or VA ID)
