"Providing Top Cover"

August 1, 2018

- 1. **Audit Reports Put This on Your Must Do List:** The quarter ended June 30, 2018. Post Commanders are reminded that it is their duty to ensure that Post Trustees comply with Section 218, page 74, Manual of Procedures Duties of Trustees. This section states in part that the Audit Report shall be signed by the Post Commander and the three Post Trustees, who shall by their signatures, "certify to the accuracy of the information contained herein". **The Audit Report is to be mailed to the Department Adjutant/Quartermaster as soon as possible**. Post Commanders, if you have complied with this section prior to the end of the month following the close of the quarter, thank you. <u>A Commander is not allowed to appoint an acting Trustee to fill in for a Trustee who is not present or to sign an audit report or any other document.</u>
- 2. **Hot Item: Bonds:** In compliance with Section 703, Page 39, National By-Laws, all Post Commanders are advised to have their Quartermaster bonded for a maximum amount of money usually in the treasury of the post at any time. Post Commanders are further reminded that old bonds expire August 31, 2018, regardless of when the bonds were ordered throughout the year. Bonds must be ordered through our State Headquarters, 3601 South Minnesota Avenue, Sioux Falls, SD 57105 by mandates of the 1974 Department Convention. The cost of Bonds is \$4.50 per \$1,000 coverage up to \$99,000 with minimum coverage of \$3,000. \$100,000 to \$349,000 is \$4.00 per \$1,000 and over \$349,000 is \$3.50 per \$1,000. **Special information** concerning Bonds has been mailed to all Post Commanders and Quartermasters with the main concern the due date is moved to September 1, 2018 and delinquent after this date.
- 3. **State Fair** District and Post Commanders, make sure that you check out the State Fair schedule and information enclosed in this General Orders. **The schedule is different than what we have used in the past.**
- 4. Post Commanders and Quartermasters should comply with all orders set out under "Duties of Commander and Duties of Quartermasters" Section 218, page 72 and 73, Manual of Procedures. This Section specifically states that all annual dues and life membership fees received by the Post Quartermaster (Department and National) shall be forwarded to National Headquarters, Direct Dues Department, PO Box 119028, Kansas City, Missouri 64171, as prescribed in Section 104, page 10 of the By-Laws.
- 5. Post Commanders whose Posts operate Post Homes are ordered to comply with Section 709, page 40 and 41, By-Laws Control of Units. Post Commanders are also directed to read Section 710, page 41 and 42, By-Laws Inspection.
- 6. Members are reminded that their conduct in the Post Home should always be respectful. People are quick to criticize unbecoming conduct in the Post Home, which usually finds its way to outside sources and leads to disrespect of the Post. A person who is disrespectful of the Post Home should be removed from the premises so that others can enjoy the facilities without interruption. A poorly operated Post Home only tends to decrease the image of the VFW and negatively influences the Post membership.
- Post Commanders and Post Hospital Chairmen are urged to insure Hospital and Safety Reports are submitted quarterly, four reports per year. Due in July, October, January & April. Report form may be downloaded via www.SDVFW.org.

- 8. Post Commanders and Post Community Service Chairmen are urged to insure the **Community Service Reports** are submitted quarterly, four reports per year Due in July, October, January & April. Report form may be downloaded via www.SDVFW.org.
- 9. **Veterans Day:** District and Post Commanders should appoint their 2018 Veterans Day Chairman. Commanders are urged to utilize all Patriotic organizations in your community to take part in the Veterans Day activities. In the event your community is not able to observe Veterans Day, join with a neighboring community and assist them in the observance of this important day. Remember, this is part of our Community Service and Americanism Programs.
- 10. Post Commanders are directed to appoint a Voice of Democracy Chairman and a Patriotic Pen Chairman. Urge your Auxiliary to appoint a Co-chairperson. These are **Post and Auxiliary "Must Programs"** for 2018 2019. Send the Chairman's name to Department Headquarters and the Department Chairman, Keith Blume P. O. Box 215, Custer, SD 57730 Home # 605-673-4143, Cell # 605-440-2331. E-Mail: krblume@goldenwest.net
- 11. It is hereby directed that all Post Commanders or Chairman of Post House Committees will not rent, lease or offer their facilities to any and all Non-American or subversive groups. If such is allowed, the Post involved will be jeopardizing their charters.
- 12. **Membership**: All life members who are reported deceased between **July 1, 2018 and August 31, 2018**, will be removed from the Post rolls and the Post's prior year membership count will be adjusted accordingly.
- 13. Post Chaplains are reminded to forward the name of each deceased comrade to the Post Quartermaster for reporting on line to National and also to the State Editor for the TAPS column of the OVERSEAS VETERAN. Reports should be sent to Dick Pickering, Editor, 404 Dogwood Street, Brandon, SD 57072. E-Mail: dickp.signs@gmail.com.
- 14. **Fall Council of Administration** of the Department of South Dakota, the Commanders and Auxiliary Homecoming, will be held at Cedar Shore Resort, Oacoma South Dakota on October 5th, 6th, & 7th, 2018. The schedule, registration and motel information are enclosed in this General Orders.
- 15. **Big 10 Conference:** Members are reminded that the Big 10 Conference will be held at the Hilton St. Louis Airport, 10330 National Bridge Rd. on October 19th–21st, 2018. Registration and Hotel forms call State Headquarters.
- 16. **Sending in Material for General Orders:** All Department Officers, State Chairman and anyone else that wants to publish information in the General Orders must submit the material to Department Headquarters or the Department Adjutant by no later than the 25th day of the month preceding the publication of the General Orders.
- 17. **District Commanders**: Please schedule your Fall District meeting ASAP between September 1 and October 31, 2018. Provide date, time and location to Department Headquarters by **August 25**th so we can publish in the September General Orders and ensure a Department Officer is available to inspect and report.
- 18. **Remember Posts** that have members that need the "Overseas Veteran" mailed to them, as proposed and approved at the State Convention, it is the POST'S responsibility to **print/mail** copies from the website.

VFW's Community Service programs, working in conjunction with such organizations as March of Dimes, Connect America and Junior and Special Olympics, are key elements of VFW membership at the Post and the Auxiliary level. These activities are designed to encourage community service and increase civic pride, which ultimately enhances education, improves the environment and ensures the availability of health services for our nations veterans.

VFW's Citizenship Education program is designed to stimulate interest in America's history and traditions and to promote citizenship, civic responsibility and patriotism.

VFW's Youth Scholarship programs include Voice of Democracy, Patriot's Pen youth essay contest and Boy Scouts of America.

The Voice of Democracy is a national audio essay program for our nation's high school students, which annually provides more than \$2.5 million in college scholarships and incentives to 9th, 10th, 11th and 12th graders across the nation.

Together with its Auxiliary, the VFW promotes annual national patriotic youth essay contest for 7th and 8th students.

The application has changed a little, please complete all blanks before sending into State Headquarters, a separate application is needed for each position (ex: Commander, Sr Vice, Sr Vice, etc.) Each bond application must be signed by either the Commander, Adjutant or Sr. Vice Commander.

The cost of Bonds is \$4.50 per \$1,000 coverage up to \$99,000 with minimum coverage of \$3,000. \$100,000 to \$349,000 is \$4.00 per \$1,000 and over \$349,000 is \$3.50 per \$1,000.

Bonding of Club Managers/Bingo Chairman/Employees

Please find enclosed a new simplified bond application for bonding Club Managers, Bingo Chairman or Club employees. <u>A new application must be submitted each year.</u> These supplies are for the bond term of October 1, 2018 to September 31, 2019. These applications can be photocopied for additional supplies. **Please issue a separate check for the club managers. Do not include with the quartermaster bond check.** Cost is \$7.00 a thousand up to \$25,000 (\$3,000 minimum). If bonding over \$25,000.00 please call State Headquarters for pricing.

We will be using the internet for the main communication source for contacting our Posts and Districts. So please contact the Department Headquarters with an email address that we can use as a contact point for your Post or District.

Application for VFW Accountable Officers Crime Coverage

August 1, 2018

One of the most important communications you will receive during the year concerns the bond of your Unit Quartermaster. Section 703 of our National By-Laws requires that each accountable officer shall be bonded with an Indemnity Company as surety and the By-Laws places the responsibility for adequate bonding upon the Commander of the post. In any business it is customary to bond any officer handling funds. THE BOOKS AND RECORDS OF THE ACCOUNTABLE OFFICER MUST BE AUDITED AT LEAST QUARTERLY BY THE TRUSTEES. THIS IS TO COMPLY WITH SECTION 218 OF THE NATIONAL MANUAL OF PROCEDURES.

The Department Headquarters carries a schedule bond for the bonding of Department and Post Accountable Officers. This bond runs for a year – from September 1 to August 31 – premium payments are made on that basis. All bonds expire on August 31 and premium for New Year is due on September 1.

Any unit may decide whether it prefers to take out a bond with some other surety company or have its funds protected by the Department Headquarters schedule bond. But the matter should be given prompt attention because if your Accountable Officer had previously been bonded through the National Headquarters, a new premium payment is required by September 1, 2018 and delinquent after this date.

IF BOND IS NOT RENEWED, TERMINATED, OR CANCELLED AT EXPIRATION DATE OF 9-1-2018, THE POST HAS ONLY 90 DAYS TO SUBMIT A PROOF OF LOSS FOR PRIOR TERM, AFTER 90 DAYS PRIOR COVERAGE CEASES.

COVERAGES OF THE POLICY REQUIRE THAT:

- 1. You agree to make/or cause to be made, at least annually, an audit of your books and accounts, including complete verification of all securities and bank balances pertaining to each "employee and/ or volunteer".
 - If the above is not complied with, the Surety Company will refuse to honor claim of missing funds which cannot be proven by records. Monthly audits and reconciliation of bank statements may avoid this denial of claim.
- 2. The Surety Company will not pay for loss resulting from any unauthorized advances made by an "employee" to any member for delinquent dues and assessments.
- 3. "Employee" means any duly elected position, as listed in the policy schedule.
- 4. POST MUST SUBMIT A PROOF OF LOSS FORM WITHIN 120 DAYS FROM THE FIRST DATE OF DISCOVERY OF THE LOSS. Proof of loss resulting from dishonest acts on the part of the bonded officer is required in settlement of claims.

THIS BOND IS ONLY FOR THE YEAR SEPTEMBER 1, 2018 TO AUGUST 31, 2019.

The funds of your Post are protected only for that year. Premium for the following year will be due September 1, 2019.

TO COMMANDERS AND TRUSTEES' (POST, DISTRICT, COUNTY COUNCIL)

As Commander and Trustees' of your District, County Council, or Post, you took an obligation to uphold the By-Laws of the National Convention and the By-Laws of your Department, District, County Council and Post.

Your attention is directed to Sections 213, 413, By-Laws: Units failing to submit properly completed Trustees' Report of Audit, on a quarterly basis, shall be deprived of all representation in County Council meetings, District, Department and National Conventions.

Article VII, Section 703, By-Laws: It shall be the responsibility of the Commander of each unit to see that the office of Quartermaster is properly and adequately bonded.

Section 218, Manual of Procedure, provides: The Post Trustees' shall, not later than the end of the month following the last day of each quarterly period, submit through the Commander a Trustees' Report of Audit to the Department Quartermaster.

Section 418, Manual of Procedure: District Trustees' shall, at each District meeting or District Convention or as Department By-Laws may provide, submit a Trustees' Report of Audit to the Department Quartermaster.

The prescribed duties of the Commander and Trustees' are obvious. The Trustees' are mandated to make the audit (or provide for an audit by qualified accountants), and submit the report. The Commander is mandated to see that the audit is made and the report properly forwarded.

The bonding of accountable officers by any bonding company is always based on the theory that the laws prescribing the duties of various officers will be complied with accordingly. Existing By-Laws relative to quarterly audits of the records of Post Adjutants and Quartermasters constitute a safeguard for the protection of the Post funds and are so considered by the bonding company in basing their rates or premiums. Laxity in enforcing and complying with the By-Laws increases the hazard of loss which in the final analysis means larger premiums must be paid. Any failure on the part of the Commander and Trustees' in performing the duties of their offices is not only a violation of trust but gives the bonding company the right to contest liability in case of defalcation.

SUGGESTIONS

When auditing the accounts of the Quartermaster by the Trustees' (Uniform Record System)

- RECEIPTS:

(1) Check duplicate copies of Miscellaneous Receipts against the entries shown in the Received Column, under heading of Cash and Bank, in the Cash Book; (2) Check names appearing on Dues Transmittal returned from National Headquarters, plus any transmittals in transit, to see that all members who have paid dues are properly credited in the Cash Book.

- VOUCHERS:

Check all properly approved Vouchers against the entries as shown in the Expended Column, under heading of "Cash and Bank" in the Cash Book.

- CASH AND BANK:

Run a total of the Received and Expended columns of "Cash and Bank" and the difference between these two columns should be the net total of Cash in bank and Cash on hand.

- CANCELLED CHECKS:

Check all cancelled checks against the Cash Book Expended entries to see if same agree. This will also show you which checks are still outstanding. Insist that all checks be countersigned by the Post Commander.

- BANK EXPENDITURES:

Run a total of all cancelled checks. Add to this total the amount of all bank charges, such as check exchange, check tax, returned checks, protest fees, etc. and the sum total of all these should be your actual Bank Expenditures. All bank charges should show as expenditures in the Cash Book.

- BANK DEPOSITS:

Run a total of actual bank deposits, add to this the bank balance as of the beginning of the auditing period and this sum represents your total bank.

- BANK BALANCE:

Deduct the total of No. 5 from the total of No. 6 and the difference should be your Bank Balance as per your bank statement.

- ACTUAL CASH BALANCE:

Deduct from your Bank Balance the amount of outstanding checks as shown by No. 4, add to this amount any and all cash on hand, and the total should be your Actual Cash Balance.

- PER CAPITA TAX RESERVE:

Compute the amount of Per Capita Tax, as shown on the Membership Record Cards, that has been paid by members and not remitted to the Department Quartermaster and see that the total amount of same agrees with the amount as shown by the Cash Book to the credit of the Per Capita Tax Reserve Fund.

- ADMISSION FEES AND DUES:

Ascertain from the records if Section 104 of the National By-Laws has been complied with.

- NUMBER OF CHECKS:

Be sure to show in your audit the numbers of the first and last checks written for the period and the numbers and amounts of all outstanding checks.

- SAVINGS AND INVESTMENTS:

Obtain a certification of all savings balances from the various depositories at the close of the audit period. Check U.S. Government bonds and other investment certificates against the master list of the Post Quartermaster. Make certain that "coupon" bonds are cashed when due and are properly credited.

- AUDIT RECORD:

It is suggested that your audit, when completed, be entered, in detail on the page of the Quartermaster's Cash Book immediately following the last entry included in the audit and all Trustees attest to the same by their signatures thereon. This then becomes a permanent record and not so likely to be lost and will always be available for reference.
