VFW Auxiliary, Department of South Dakota has been awarded a Christmas Tree at the State Capitol!

DEADLINE for decorations is November 11th. Christmas at the Capitol Lighting Ceremony will be Tuesday, November 24th at 6:30 pm. <u>Because of the location of our tree, we cannot decorate it</u> until after the ceremony – Wednesday, November 25th beginning at 9:00 am.

The 2015 Christmas at the Capitol theme is "Christmas Around The World". This is a perfect way to show off our Veterans who have certainly been around the world to protect our freedom!

On a small mouth jar flat, put a COPY of your beloved veteran's photo along with veteran's name, rank & years served.

On the other side of the flat put a copy of the map where served (such as US map, Iraq map, etc. Also be sure to include auxiliary name & town (type or print). Decorate as you like, but keep it all on the front and back of that small mouth jar flat $(2 \frac{1}{2})$ in diameter).

Poke a nail hole in the top & bottom of the flat. We are going to wire them together and they will run vertically down the length of the tree with both the front and back visible.

Do not use original photos – there is always a chance of loss or damage.

If selected, we will need your decorations by Veterans Day, November 11 so that we can get everything assembled to decorate the tree on November 22.

If not selected, your decorations can be proudly displayed on your post or local courthouse tree.

Ladies wearing a man's shirt will not be considered to be in the "official look." New patches placed over the present patch on the ladies blouse will not be considered "official." Remember, we do have five (5) years, and personally, I believe each individual needs to take into consideration their position and where and when they are representing the Auxiliary to decide how they wish to deal with this.

Retreat – I hope that many of you are planning to attend the retreat in Grenville on November 16 - 19, 2015. What a great way to learn more about the Auxiliary, have some fun, and network with other members. If you can't come for the whole retreat, please join us for at least a day.

President Nancy Worth called the meeting to order at 8:30 AM. Guard Donita Mullinex reported the badges were checked at the door. Opening Ceremonies were conducted according to ritual. Secretary Nancy Chester took Roll Call of Officers. All Council members were present except Past Department Presidents on Council Neta Peterka and Vickie Rosse and National District Council member Vicki Rosse.

Roll Call of Past Department Presidents: present were Janice Vreim, Mildred Ratigan, Nelda Jorgenson, Gloria Fortin, Imogene Ellis, Nancy Chester, Carol Gross, Connie Heggestad, Mary Hammond, Jan Endes and Vicki Williams.

Roll Call of Auxiliaries: present were District 1 – Alcester 1, Canton 1, Beresford 2; District 2 – Brookings 5, Madison 1, Sioux Falls 2; District 4 – Milbank 2, Sisseton 2, Watertown 2; District 6 – Aberdeen 2, Redfield 1, Huron 1; District 7 – Plankinton 1; District 8 – Pierre 9, Winner 1; District 10 – Custer 4, Sturgis 2, Rapid City 3, Deadwood 2.

Opening Prayer by Chaplain Mary Kirkvold and Pledge of Allegiance by Nelda Jorgenson. President Worth shared the basket exercise where members mentally or physically write down what you dislike about a person in the meeting room. You then put it in the basket to leave any feelings of difference behind while in the meeting.

President Worth presented National Representative Sandra Onstwedder, National Guard 2015-2016. She is from White Cloud, Michigan and was elected National Guard at the 102nd National Convention in Pittsburgh, PA on July 22, 2015.

Reading of the minutes of the previous meeting: Chief of Staff Jan Endes motioned to dispense with the reading of the previous meeting since they were in General Orders. Conductress Sandi Moss 2nd. Budget Report: Janice Vreim gave budget report. During report National Guard Onstwedder was asked why South Dakota didn't get any discounts from purchasing items through the national supply department. National Guard Onstwedder remarked we may not have purchased enough items to be eligible for discount. Items purchased at National Convention do not count toward discount awarded. Conductress Moss motioned to approve Budget Report.

Junior Vice President Alm 2nd. Motion Carried.

President Worth thanked Gerri Dahlin for Homecoming decorations; Dorinda Timmons for stepping in as Soloist and Zoe Yellin for helping with the Veterans and Family Support program during School of Instruction; and Lois Ladegaard for helping Sandi Moss.

Reports of Committees, standing and special:

- Veterans & Family Support no report. Zoe Yellin gave School of Instruction for Patti Mitchell.
- Americanism Nelda Jorgenson reported that School of Instruction had good discussion on Saturday.
- Hospital Leanne Payne also reported Saturday's School of Instruction was good and contact her if any questions.
- Legislative Tammy Chase commented on the Agent Orange Claim Forms
- Membership Carrie Alm said Thank You for allowing her to sign the "No Excuse Just Recruit" contract. She will do calls for any Auxiliary that needs help or the extra push to get membership dues paid.

- Scholarships Sandi Moss said it is never too late to get a scholarship application and Saturday was a good give and take forum.
- Youth Activities Mary Kirkvold remarked how well the new School of Instruction format worked and how much she learned from other members.
- Extension/Chief of Staff/National Recruiter Trainer Jan Endes asked members to try to form an Auxiliary in the bachelor Posts. She has the new membership forms for Auxiliary, but the full sheet form is needed by Treasurer Gross.
- State Fair President Worth reported the hours worked by VFW of 457 hours and the Auxiliary of 345 hours, but these hours don't have travel time included.
- Capitol Christmas Tree Deb Fahey asked for small mouth jar flat with a COPY of your beloved veteran's photo
 along with veteran's name, rank & years served. On other side of the flat put a copy of the map where served

Guests: South Dakota VFW Commander Mike Mullen, VFW National Councilmember & National Representative DD Couch and SD VFW Chief of Staff Ken Payne were escorted into the meeting room. Assistant Soloist Dorinda Timmons sang a song to Representative Couch. Commander Mullen stated the year is going well thus far and looks forward to a good working relationship between VFW and VFW Auxiliary.

President Worth called for a 15 minute break while National Representative Onstwedder, Chief of Staff Endes and herself visited the VFW meeting. Chaplain Kirkvold closed the Bible.

Senior Vice President Sharp resumed the meeting. Chaplain Kirkvold opened the Bible.

Convention Committee – Carrie Alm reported 49 VFW and 61 auxiliary members were registered. Information regarding Convention Booklet ads is available and will be in November GOs. The advertisement submission form will be put on the Departments website by mid-week.

Training – Junior Vice President Carrie Alm explained about a 4 night and 3 day training session that is open to 30+ auxiliary members from Nov 16-19, 2015 at the Roost. More information and Agenda will be in GO's.

Cemetery Council – Kay Rypinski explained the history of the Avenue of Flags. Maintenance money comes from donations. The council spends about \$4,000 per year to keep serviceable flags, halyards and snaps on hand. We can send checks to Treasurer Gross earmarked SD Veterans Cemeteries Support Council.

Ways & Means – Marion Grant reported collecting \$250+.

President Worth, National Representative Onstwedder and Chief of Staff Endes returned to the Auxiliary meeting. Assistant Soloist Dorinda Timmons sang a song to Representative Onstwedder to the tune of the Navy song.

President Worth asked how many 1st timers we had at the meeting. There were three 1st timers.

Unfinished Business: President Worth reported last year's Cancer Aid & Research Chairman Carrie Alm presented Simon Bordeaux of Walking Forward/Avera Program a donation in the amount of \$2,760.73 at Saturday's School of Instruction.

Awards received at the VFW Auxiliary National Convention in July 2015:

- Carrie Alm for Cancer Aid & Research Program received Runner-Up to the Outstanding Performance Award Citation in Membership Group 6. The Department received \$100.
- Nelda Jorgenson as Chief of Staff received Runner-Up to the Outstanding Performance Award Citation in Membership Group 6. The Department received \$100.
- Jan Endes for Legislative Program received Runner-Up to the Outstanding Performance Award Citation in Membership Group 6. And the Department received \$100. SD received 1st Place Fireworks Gift Certificate in Membership Group 6 for the Best Promotion of encouraging all members to sign up to receive VFW Legislative Alerts.

- Karen Sharp for Membership received 1st Place in the Outstanding Performance Award in Membership Group 6 and received a "Patriotism Begins at Home" Plate. The Department received \$200.
- Lois Ladegaard for Scholarships Program received 1st Place in the Outstanding Performance Award in Membership Group 6 and received a "Patriotism Begins at Home" Plate. The Department received \$200. SD received 1st Place Fireworks Gift Certificate in Membership Group 6 for the Best Promotion of the Recognition of Voice of Democracy and Patriot's Pen Contest Winners.
- Past Department President Vicki Rosse received Runner-Up to the Outstanding Department President Award in Membership Group 6. She received an etched lead crystal vase.
- Secretary Chester read the 1st Place National Buddy Poppy Divisional Competition Award for 2014-2015. This award was sent to the Department of South Dakota Auxiliary after National Convention in July 2015.

New Business: President Worth had Standing Rules Committee - Senior Vice President Sharp give recommendations. Senior Vice President Sharp motioned to amend all areas of Ladies Auxiliary to reflect Auxiliary name change; areas of she to she/he and her to her/his to reflect gender neutral changes; areas saying corsages to corsages/boutonniere and in V. A. the last sentence be changed to read "A special fund may be either permanent or temporary and shall consist of all monies received with the understanding that <u>said fund is dedicated</u> to the purpose indicated". Conductress Moss 2nd. Motion Carried.

It was noted that item 1. D. "Each year the Incoming Department President <u>may</u> choose a fundraising project as her Special Project. The project should state what the funds raised will be used for" was deleted in June 2012.

Senior Vice President Sharp motioned to delete item 4. b. Cancer and make amount Forty Dollars (\$40) for remaining programs effective immediately. Junior Vice President Carrie Alm 2nd. Motion Carried.

Senior Vice President Sharp motioned to change K. 2. to read "The Gold Star Family Recognition Luncheon Fee – The Department shall pay for two (2) lunches per Gold Star Family in attendance, the Department President and the National Representative. Conductress Moss 2nd. Motion Carried.

Senior Vice President Sharp motioned on IV. At bottom to add "Monthly vouchers to be submitted to Treasurer by end of each month to receive payment." Conductress Moss 2nd. Motion Carried. Discussion was held on whether a voucher is needed. Consensus was yes.

Senior Vice President Sharp motioned to add in III. TRAVEL a second sentence "Airfare shall include baggage fee for one (1) bag." And Plane fare in all areas be changed to Airfare. District #10 President Diane Ward 2nd. Motion Carried. Senior Vice President Sharp motioned to change IV. STIPEND to ALLOTMENT and all other areas be changed from stipend to allotment. District #6 President Sheryl Ruckman 2nd. Motion Carried.

2016 Legislative Conference: Since VFW changed the 2016 Legislative Conference held in Pierre, SD to January 31 and February 1, 2016 Junior Vice President Alm motioned to move the Auxiliary meeting date to Sunday, January 31, 2016 at 10 AM. Senior Vice President Sharp 2nd. Motion Carried.

President Worth announced who would be the representatives to the upcoming District Meetings. She also reviewed that the Big Ten Conference Delegates will be President Worth; Senior Vice President Sharp; Junior Vice President Alm; Chaplain Kirkvold and Conductress Moss. Alternates will be Treasurer Gross; PDP on Council Vickie Ross; National Recruiter Trainer Jan Endes; Guard Donita Mullinex and Nelda Jorgenson.

Department President and Commander's Project is the VFW National Home for Children. President Worth had a bank available for contributions and said might be a good time to lighten your purse of some heavy coins.

Suggestions for the Good of the Organization: Any suggestions for the 2016 Legislative Conference should be directed to Senior Vice Commander Sharp and Senior Vice President Sharp. Junior Vice President Alm noted that donations to VA Hospital in Hot Springs are down by half. She asked where past Department Meeting minutes were kept as she would like to review. Members believe all records are in the Sioux Falls VFW Department Office.

President Worth explained hand outs on how Auxiliaries should change their name as soon as possible; if Incorporated change through the SD Secretary of State after getting written approval of Post Commander; and change Employer Identification number with the IRS. She reviewed a regular member who changes to a Life membership is not a transfer.

President Worth asked National Representative National Guard Onstwedder to give her comments. National Guard Onstwedder brought greetings from National Headquarters. She asked that we do our best for organization and donate to Veterans and Family Support Program. The Cancer Program is gone, but the Cancer Grant is still available when you use the new form. The \$2 per member is not tracked. The National Program Booklet is available online and in loose leaf form. She closed with giving her guides, Jan Olson and Donita Mullinex and President Worth gifts.

Closing Ceremonies: Were conducted according to ritual. The next meeting will be the Legislative Conference in Pierre on January 31, 2016.

STANDING RULES **Updated October 4, 2015**

I. DEPARTMENT

- A. Budget Committee shall consist of five members: Senior Vice President, Junior Vice President, Chaplain, and one (1) Past Department President as Chairman, and one other appointed by the incoming Department President. The Department Treasurer shall prepare the budget for the next year. The committee shall meet prior to the Department Convention to establish the budget for the next year. Notification of time and place of meeting to be sent out by the Budget Chairman. Such budget shall be approved at the first Council Meeting immediately following Department Convention.
- B. Auxiliary Presidents' Judging Committee: The Chairman and Committee (not to consist of more than three [3] members) shall be appointed by the incoming Department President. The committee will prepare the judging criteria and publish in the first General Orders mailing. The Committee shall examine the reports of Auxiliary Presidents submitted at the end of the year. The committee shall serve as the "Judging Committee" to select the winners in the "All-State President" competition.
- C. Mileage shall be allowed for the purpose of exchange of paraphernalia from the retiring President, Secretary, and Treasurer to the incoming President, Secretary and Treasurer.
- D. Mileage of thirty (30) cents per mile shall be allowed for all travel as set out in these Standing Rules from home station to destination and return. (6/6/2012)
- E. Hotel expense: Any Department Officer at the direction of the Department President, who travels more than 200 miles one way to an official function shall be reimbursed not to exceed \$70 for one night, should she/he choose to stay overnight. If adverse weather conditions occur and safety becomes a factor, it is at the discretion of the officer to make the decision to spend the night.
- F. Receipts for all vouchers expenses are required (including hotel) by everyone.

If a continuous District President, she/he must attend both C of A meetings at Department Convention to receive round trip mileage; otherwise, she/he will only receive one-way mileage.
- 6. Miscellaneous Mileage (General Fund)
 - a. To designated member of organization, appointed by the President, for one (1) trip to Institute an auxiliary and one (1) trip for a return visit within three (3) months after Institution for the purpose of instruction.
 - b. To Chief of Staff or a representative appointed by the President to visit a Post, if they are interested in forming an Auxiliary.

- c. To Chief of Staff or a representative appointed by the President for trips to assist Auxiliaries who are having difficulties.
- d. To Audit Committee members and Department Treasurer to and from point of audit (Includes: Dept. Jr. Vice President, Dept. Chaplain, one (1) Council Member) each year for periods ending June 30 and December 31.
- e. To Convention Credentials Committee Chairman-to and from Department Convention.

C. HOTEL ALLOWANCES (General Fund)

- 1. Fall and Legislative/Midwinter Council of Administration Meetings
 - a. Department President her/his share, not to exceed one (1) night for Fall and two (2) nights for Legislative/Midwinter C of A meetings.
 - b. Department Secretary her/his share, not to exceed one (1) night for Fall and two nights for Legislative/Midwinter C of A meetings.
 - c. Department Treasurer her/his share, not to exceed two (2) nights for Fall and two (2) nights for Legislative/Midwinter C of A meetings
- 2. Department Convention
 - a. Department President her/his share, not to exceed four (4) nights
 - b. Department Secretary her/his share, not to exceed four (4) nights
 - c.. Department Treasurer her/his share, not to exceed four (4) nights
- 3. State Veterans Service Officers Conference: (If there is one)
 - a. Department President hotel shall be allowed.
- **III. TRAVEL** (**General Fund**) When mileage or airfare is utilized, the least amount will be paid. Airfare shall include baggage fee for one (1) bag. Round-trip mileage from home to airport to home will be paid.

A. National Convention

- 1. Department President Airfare and ground travel. Hotel her/his share not to exceed five (5) nights, and Two Hundred Dollars (\$200) expenses;
- 2. Senior Vice President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses;
- 3. Immediate Past Department President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses.

B. Big Ten Conference

- President Airfare and ground travel. Hotel her/his share not to exceed two (2) nights, and Two Hundred Dollars (\$200) expenses;
- 2. Senior Vice President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses;
- 3. Junior Vice President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses.

VFW Auxiliary Department of SD Standing Rules 2015 as of October 4, 2015

- C. Midwinter Conference
 - 1. President Airfare and ground travel. Hotel her/his share not to exceed four (4) nights, and Two Hundred Dollars (\$200) expenses;
 - 2. Senior Vice President Airfare and ground travel, and Two Hundred Dollars (\$200) expenses.
- D. Community Service/VOD Convention, Washington, DC
 - 1. President will be allowed up to Seven Hundred Dollars (\$700.00) expenses to attend the Conference.

IV. ALLOTMENT

- A. President Fifty Dollars (\$50) each month while in office.
- B. Secretary Fifty Dollars (\$50) each month while in office.
- C. Treasurer One Hundred Dollars (\$100) each month while in office.

Monthly vouchers to be submitted to Treasurer by end of each month to receive payment.

V. FUNDS AND RECEIPTS

- A. Special Funds: The Department Council of Administration or Department Convention may, from time-to-time, establish special funds for specified purposes. A special fund may be either permanent or temporary and shall consist of all monies received with the understanding that said fund is dedicated to the purpose indicated.
- B. All Department awards (not personal) received from the National VFW Auxiliary shall go into the General Fund.

VI. FUNDS AND EXPENDITURES (General Fund)

- A. All expenditures, either authorized or payments made shall, at all times, be made within and governed by the provision of the Department Budget.
- B. Vouchers and an itemized bill of purchases shall be submitted to the Department President for approval before the Department Treasurer will make payment. All bills shall be submitted for payment before or during the Department Convention for current year expenditures. All vouchers must be submitted to Department Treasurer no less than one (1) month after the event covered by the vouchers.
- C. All parties receiving funds for hotel, airfare, ground travel, etc., shall send receipts of same to the Department Treasurer to be attached to vouchers supporting claim for payment or reimbursement.

- D. All expenses incurred, not covered by the budget, shall be submitted to the Budget Committee for approval and voted on by the Council of Administration.

- F. State Fair Dept. will pay one (1) round-trip mileage for Auxiliary Chairman, and week gate pass, camping fee and parking fee for both VFW and Auxiliary Chairman be allowed (taken from State Fair Fund). Department will pay for one (1) golf cart not to exceed Three Hundred Fifty (\$350.00) yearly if VFW does not pay.
- G. Contingencies
 - 1. President One Thousand Dollars (\$1,000) payable upon receipt of vouchers by Department Treasurer;
 - 2. Senior Vice President Two Hundred Dollars (\$200) payable upon receipt of vouchers by Dept. Treasurer;
 - 3. Secretary Six Hundred Dollars (\$600) payable upon receipt of vouchers by Dept. Treasurer;

Designated delegates are: Department President, Department Sr. Vice, Department Jr. Vice, Membership Chairman (if not one of top three officers) and one (1) to be selected by the Council of Administration with consideration given to any member who may hold an office in the Big Ten Conference.
 - 2. Department Chaplain is responsible to send a memorial in deceased person's name to benefit a VFW or Auxiliary Program not to exceed Twenty-five Dollars (\$25) in case of the death of:
 - Department Officer elected or appointed, Program Chairman, including VAVS and deputy representatives, Past Dept. President of the VFW Auxiliary (includes husband, wife, child, mother, and father), VFW Dept. Commander, VFW line officers. NOTE: In case of the death of a Past Dept. President, her/his spouse, the Department President shall notify the President of the Past Presidents' Club. The President is noted by two asterisks (**) on the roster.
 - 3. The Department Chaplain is responsible to send remembrance, not to exceed (NTE) Fifteen Dollars (\$15). In case of hospitalization of the VFW Department Commander, Auxiliary Department Officer, Program Chairman, VAVS representatives and deputy representatives, or Past Dept. Presidents.
 - 4. Greetings to other Patriotic Organizations shall not exceed Ten Dollars (\$10) per organization.
 - 5. A love token not to exceed Twenty Dollars (\$20) shall be given each year from the Department for the National President's gift at the National Convention.
 - 6. The Department shall purchase a combined Podium Edition of the Bylaws and Ritual each year National Headquarters publishes revisions to be presented to the incoming Department President, Sr. Vice President, Jr. Vice President, Treasurer, Secretary, Chaplain, Conductress, Guard, Chief-of-Staff, Musician and all seven (7) District Presidents.
 - 7. Corsages/boutonnieres shall be provided (as deemed appropriate) by the Department to the Department President at the Big Ten Conference and Mid-Winter Conference banquets. The Dept. Sr. Vice President is responsible for the ordering corsages (working with Dept. Treasurer) for the Big Ten and Mid-Winter Conference banquets if: the Department has a National Council Member, National Director/Ambassador or Big Ten Officer/Chairman.
 - 8. Thirty Dollars (\$30) shall be allowed from Department Funds to purchase a gift and/or flowers to be presented to the outgoing Department President immediately following the National President's luncheon/dinner at National Convention. Incoming Dept. Sr. Vice President shall be responsible for purchase of gift and ensure all at Convention know location and time of luncheon/dinner, so they can be present for the presentation.
 - 9. Funds shall be allowed for four (4) first place All-State Presidents and four (4) runner-up awards. President to select awards to be presented. The four (4) membership categories are: 10-50; 51-110; 111-225; and 226 and over.

- K. MISCELLANEOUS ALLOWANCES (Department Convention Fund)
 - 1. The Department Convention Registration The Department shall pay for the Department President and National Representative.
 - 2. The Gold Star Family/Recognition Luncheon fee The Department shall pay for two (2) lunches per Gold Star Family in attendance, the Department President and the National Representative.
 - 3. Stipend Assistant Secretary Ten Dollars (\$10 for services rendered at the Department Convention.
 - 4. Stipend Secretary Thirty Dollars (\$30) for services rendered at the Department Convention and to prepare Department Convention minutes within two (2) weeks following the convention.
 - 5. Stipend Soloist/Assistant Soloist Fifty Dollars (\$50) shall be allowed for soloist at Dept. Convention. If soloist and assistant soloist both provide services, the Fifty Dollars (\$50) shall be divided between them Twenty-five Dollars (\$25) each.
 - 6. Stipend Musician/Assistant Musician Fifty Dollars (\$50) for services rendered at Dept. Convention. If Musician and Assistant Musician each provide services, the Fifty Dollars (\$50) shall be divided between them Twenty-five Dollars (\$25) each.
 - 7. Memorial Book prepared by Department Chaplain not to exceed Seventy-five Dollars (\$75).
 - 8. Department Convention Committee to purchase corsages and boutonnieres for the Auxiliary President, Commander, and National Representatives to identify them throughout the convention.

VII. MAILING

- A. The Department Secretary in office shall prepare the Auxiliary roster as soon as possible after election of Auxiliary Officers in April of each year. The completed roster shall be provided to the incoming Dept. President for inclusion in her/his first General Orders. On the Past Dept. Presidents Roster, identify President of Past Presidents' Club with two (2) asterisks (**).
- B. Beginning with the 2015-16 year, the Department Roster and Auxiliary Roster, all General Orders, Standing Rules, Special Orders, memorandum or bulletins, shall be emailed and posted on the Department SD VFW website (www.sdvfw.org) to all Auxiliary Department Officers, District Presidents, Dept. Chairman, all Auxiliary Presidents, Treasurers, and Secretaries, Past Dept. Presidents, National Auxiliary Council Member #23, VFW Dept. Commander, Sr. and Jr. Vice Commanders, Adjutant, VFW Dept. Headquarters, and VFW National Council Member. One (1) printed copy will be mailed to each Auxiliary President for distribution within the Auxiliary only by request or request by email only.
- C. It shall be the responsibility of the Dept. Secretary to update, make any corrections or additions of the Standing Rules each year.

D. An updated electronic version (of the Standing Rules) shall stay in the possession of the Dept. Secretary and emailed to Assistant Secretary, the Treasurer, and the President.

VIII. MISCELLANEOUS

- A. The Department President may appoint an Assistant Treasurer, who may sign checks in the event the Department Treasurer is disabled. Before implementing, National Headquarters must approve the process.
- B. The outgoing Department President, Secretary, and Treasurer, shall prepare an inventory of the property in her/his possession that belongs to the Department. The inventory will be included in the convention Officers and Chairman Report Booklet. This inventory shall be turned over to the incoming Department President, Secretary, and Treasurer.
- C. If any of the sponsored veterans' facilities (Fort Meade VA, Royal C. Johnson VA, Hot Springs VA, SD Veterans Home and Yankton Human Services) find it is in need of a special purchase to benefit veteran residents, the VAVS or hospital representative will request a letter of need be sent to the Department President and Treasurer with details of the need and the cost involved. As Canteen Books are needed by the above mentioned facilities, VAVS or hospital representatives will purchase the books and make them available to VA or hospital staff.
- D. Member-at-Large dues will be Forty Dollars (\$40). (Resolution passed 6/16/2007)

IX. DISTRICT FUNDS

- A. Mileage to and from District meetings and one inspection to each auxiliary in the District to be paid to the District President upon submitting a voucher at rate approved by District.
- B. Each District shall purchase from District Funds, Bylaws and Rituals for all officers it deems necessary to carry out efficiently the work of the District (Department will provide to Bylaws and Ritual to District President).

Tenn., Ohio, La., Ind. and Miss. join the union. Congress mandated the number of stripes be fixed at 13 and a star would be added for each new state.

May 1, 1795



After Vermont and Kentucky join the union; 15 stars and stripes adopted.

August 1777



The "Bennington Flag"; carried at the Battle of Bennington.

1777



Used by the 3rd Maryland Regiment; carried into battle January 1781.

The "Betsy Ross" flag. Stars represent the newly formed 13 states — Del., Pa., N.J., Ga., Conn., Mass., Md., S.C., N.H., Va., N.Y., N.C. and R.I. January 1776



"Grand Union" flag. In the "union" square are the crosses borrowed from the British flag.

WHAT THE COLORS MEAN

The colors red, white and blue did not have meanings for the Stars and Stripes when it was adopted in 1777. However, when the Congress of the Confederation chose red, white and blue for the Great Seal of the United States in 1782, the meanings were listed as:





A PROPER DISPLAY

Flags should always hang freely but never with the stars down, except as a distress signal.




When displayed in a window, the flag should have the "union" to the left of outside observers.

- No other flag may be flown above or to the right of the U.S. flag, except at the United Nations headquarters.
- A flag should never touch the ground.
- Citizens may fly the flag at any time but preferably from sunrise to sunset except for special occasions or when well-lighted.
- When a flag becomes unfit to fly, it should be destroyed with dignity.

FOLDING THE FLAG

Folding the flag into a neat triangle doesn't have to be difficult.
Here's how:

- Hold the flag at waist level with another person so its surface is parallel to the ground.
- 2 Fold the lower side with stripes over the side with the "union."
- Sold again so the union is on either side, facing the ground and sky.
- Fold the end diagonally to form a triangle, then continue folding until a blue triangle is visible.

Having recently returned from the Fall Council of Administration, I have more questions than answers!! One of the many asked questions was about the Hospitalized Veterans Writing Project. Here is information I found that I trust will help you understand the project:

The Veterans Voices Writing Project (VVWP) is a unique and worthwhile project. It was formally known as the Hospitalized Veterans Writing Project. VVWP is designed to utilize writing as therapy for veterans. Writing aides, writing group leaders, volunteers and/or Veterans Administration medical center staff encourage veterans to write. In 1952, the magazine, Veterans' Voices, was created to encourage veterans by publishing their work. Since that time, this 64-page magazine has been published three times per year (Spring, Summer and Fall).

Veterans often experience traumatic and life-changing experiences in the service of their country. Through the coordinated efforts of VVWP volunteers and/or VA medical center staff, veterans across the United States are encouraged to write as therapy. They may submit their manuscripts (prose, poetry and artwork) for publication in Veterans' Voices, the only publication dedicated solely to veterans' writings.

It can mean so much to a veteran when a story, poem or artwork is published in Veterans' Voices magazine, proving again that love (and writing) is still the best medicine. Veterans are looking for a helping hand to bolster their self-esteem, to make them proud to have served our country. These veterans, whatever their disabilities, need to know that while their service is interrupted, they are not forgotten. VVWP has gone to great lengths to instill in the hearts of veterans a pride of accomplishment, a reward for an endeavor well done. As long as men and women dream, Veterans' Voices will be there to fulfill those dreams.
